- a. 2023-GEDTF-142 City was awarded \$75K for an estimated \$285K project. Council will need to prioritize which properties to demolish (11, 13 15, 17, 19, 21, 23, 25, 27, 29, 31,32, 33, 125 S. 7th St; 733 Klere; 138 and 151 Aurilles). My recommendation is to bid out 32, 33, and 125 S. 7th St; 733 Klere St; 138 and 151 Aurilles St as the base bid and add 11 to 31 S. 7th St. as an alternate.
- b. CD49 Safe Neighborhood Grant City was awarded \$75K for an estimated \$100K project. The selected addresses are 16, 18, 28, 30, 35, 119, 121 S. 7th St. City is going to proceed with contract bidding unless directed otherwise.

c. Proposed Grant Applications: City Manager Sample and Laura Branthoover

- b. Home Rule Charter
 - i. City Council will adopt Ordinance forming the Government Study Commission (GSC) (Council will need to decide if the 7, 9, or 11 members) Those running for GSC must obtain signatures of registered voters of at least 2% of votes cast in last election (will need approximately 30-35 signatures to get on the ballot for the November ballot)
 - ii. GSC will follow same process and timelines as those running in the Primary Election
 - iii. GSC will either recommend no change after 9 months of study or must produce report to DCED with proposed changes after 18 months
 - iv. Home Rule will give the City the authority to increase its resident Wage Tax rate, which is needed because the City is no longer under Act 47. Home Rule is a step a majority of communities exiting Act 47 have undertaken.
