**A RESOLUTION OF THE CITY OF DUQUESNE OF ALLEGHENY AND COMMONWEALTH OF PENNSYLVANIA ESTABLISHING WAGES FOR ALL CITY EMPLOYEES NOT REPRESENTED BY A COLLECTIVE BARGAINING UNIT, FOR THE YEAR 2025, SAID INCREASE TO BE EFFECTIVE AS OF JANUARY 1, 2025**

**WHEREAS**, the Council of the City of Duquesne after due deliberation has determined that the non-bargaining unit employees shall be entitled to salaries as listed below for the year 2020.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the City of Duquesne and it is hereby resolved by and with the authority of the same:

**FIRST:** All City of Duquesne employees not represented by a collective bargaining unit for 2025 shall be entitled to salaries as listed below effective as of January 1, 2025.
