# 2011—2012 APPLICATION FOR RE-ENROLLMENT

Those students who wish to return for the 2011—2012 academic year and would like to take advantage of the early discount must do so before May 18. After May 18 the tuition amount will increase.

Those students who wish to return for the 2011—2012 academic year but do not wish to take advantage of the early discount must still re-enroll before June 30. Failure to do so will forfeit the student's place in school. Simply meaning, after June 30 enrollment is first come, first serve. Keep in mind that maximum class size is relatively small, if the class fills up with new students you will be placed on a waiting list.
