A public hearing to consider the proposed rate increase will be conducted by the County Sanitation District #2-3 (CSD2-3) Board of Directors on May 21, 2024, commencing at 9:30 a.m., in the Board Meeting Chambers located at 70 West Hedding Street, San José CA 95110.

If you wish to oppose the proposed rate adjustments, to be considered your protest must be submitted in writing, contain a description of the parcel, be signed, and must be received prior to the close of the hearing. The best means of identifying the parcel(s) is by the Assessor's Parcel Number (APN). If a majority of affected parcel owners submit written protests, the proposed rate increase will not go into effect. Written protests are accepted by mail to the Clerk of the Board of Directors, CSD2-3, 70 West Hedding Street, San José, CA 95110 or in person at the public hearing on the date and time specified.

If you desire any additional information concerning the proposed rate increase, please contact CSD2-3 at 408-255-2137. If the Board approves the proposed rate at the May 21, 2024 hearing, new rates will be included in the Sewer Service Charge collected with the Fiscal Year 2024-2025 Tax Roll. Prior to the public hearing, two Public Meeting Workshops will be held to discuss the need for the rate increases. The meetings will be held on May 14 at 1:00 p.m., and May 16, 2024 at 6:00 p.m. via Zoom. NOTICE OF PUBLIC HEARING: PROPOSED SANITARY SEWER SERVICE CHARGE RATE CHANGE

Dear Property Owner:

County Sanitation District No. 2-3 (CSD2-3) has experienced steadily rising operating and capital improvement costs, to the extent that CSD2-3 must now draw upon its cash reserves for payment of these expenses. The sewage treatment facilities operated by the City of San José, which the CSD2-3 uses, has been undergoing substantial equipment upgrades and improvements over the past several years to comply with state and federal regulatory requirements and CSD2-3' s share will be approximately \$2.8 million dollars over the next five years. Maintenance and repair costs have also been increasing and CSD2-3 is completing capital projects to replace portions of the system that are critical to maintain continued service and prevent sewer spills. To cover CSD2-3' s normal operating costs and its share of the cost to upgrade and improve the sewage treatment facilities, sewer service charges must be increased as follows:
