

**I, Michael W. Bright, the undersigned Affiant,** hereby make the following statement as true & correct to the best of my knowledge:

**1.** Pursuant to KY RCr 2.02, the county attorney (or assistant, thereof) or the Commonwealth attorney (or assistant, thereof), as representatives of the KY Commonwealth, must file a signed factual Complaint in court to initiate a criminal case against a defendant.

**2. On or about July 17, 2013,** I requested from the Jefferson County court clerk's office any criminal Complaint, pursuant to KY RCr 2.02, filed to initiate Case 13-CR-01509, but the court clerk **has not** provided me with any such Complaint from the court record. The court clerk told me **no such** Complaint by the Commonwealth is filed in the court record. My son, Nathan Bright, is the alleged defendant in 13-CR-01509.

**3.** Wherefore, I have verified with the court clerk that the KY Commonwealth **has not** filed any criminal charges against Nathan Bright in 13-CR-01509, as otherwise required by KY RCr 2.02.

**AFFIDAVIT #2** of Michael W. Bright

Filed in: CASE: 13-CR-01509, Jefferson County Circuit Court

**RE: I called 911 to Report Nicole Estas breaking into Our / Nathan Bright's home on March 24, 2013**

**I, Michael W. Bright, the undersigned Affiant**, hereby make the following statement as true & correct to the best of my knowledge:

1. As of March 24, 2013, my son Nathan Bright's ex-girlfriend, **Nicole Estas**, had an outstanding domestic violence order on Nathan. Estas has a longtime history of attempted suicide, mental illness, and is currently being treated for mental illness. Nicole's treatment includes her taking medication.
2. On Sunday morning March 24, 2013, at approx. 8:58 a.m. I heard a loud noise at my back door. While putting on my pants, I heard Nathan call-out, "Get-off me, Nicole." I then heard Estas screaming at Nathan, and he called-out to me, "Dad, call the police."
3. As I came down the stairway, I called 911 to report Estas breaking-in our home. And I saw Nicole exiting the backdoor as I came down the stairway. I gave a description of Nicole and her vehicle to the 911 operator. Approx. 4 minutes later, LMPD Lt. Williams came in our home to inform us that Nicole had been apprehended.
4. At the scene of my home on 3-24-2013, Lt. William wrote-up his Report as Nathan being the victim of perpetrator Nicole Estas.
