Due to Highly Pathogenic Avian Influenza detections in the Commonwealth, a signed General Quarantine order went into effect on April 16th, 2022. The order, titled 52 Pa. B 2223 General Quarantine Order; Cancellation of Exhibition of Poultry and Their Hatching Eggs Due to Highly Pathogenic Avian Influenza, prohibits the display, exhibit or presence of poultry, poultry products, including eggs, poultry parts or any goods or items containing or made up of poultry products such as feathers, or poultry parts at ANY exhibitions or other such venues within the Commonwealth of Pennsylvania which receive funding pursuant to the Pennsylvania Agricultural Fair Act 3 P.S. § 1501 et seq.

This order remains in effect until officially rescinded by the Department.

2023 EXHIBITION RULES

Due to Quarantine order exhibitors are being offered three replacement events. A poster contest, showmanship, and a nest decorating contest.

- 1. Registration is \$5.00 per exhibitor unlimited entries per class.
- 2. Each exhibitor is responsible for lanyard registrations. Lanyard form links are located on our website https://cambriacofair.com/ or https://sites.google.com/view/american-legion-co-fair/home If you have any problems accessing these sites please email us at ccfair@verizon.net.
 - Lanyard registrations submitted after July 14th will not accepted. Exhibitor Lanyards are \$10 and Family Lanyards are \$20 each.
