## BALSLEY PAVILION RENTAL AGREEMENT

### FEE SCHEDULE

Includes: Pavilion and Spring House (Restroom Facilities & Refrigerator) - - - - - **\$75.00 per day**

### GENERAL POLICIES & RENTER RESPONSIBILITIES

1. **ALL** set-up and clean-up is the responsibility of the Renter
2. Smoking and drug use is **NOT** allowed anywhere on Historical Society property.
3. Lewd, illegal or disruptive behavior will not be tolerated.
4. Renter is required to place trash in the container(s) provided at the entrance of the property
5. **DO NOT TAPE, STAPLE, NAIL or ATTACH IN ANY OTHER WAY** item(s) to the pavilion structure. The pavilion took lots of money, time and effort to build, so please treat it with the respect it deserves. Treat it as if it was yours.
6. Banners, signs and other such items **MAY NOT BE TAPED, NAILED, STAPLED OR ATTACHED IN ANY OTHER WAY** to the pavilion. If you need to have your banner/sign displayed inside or outside, arrange to have freestanding poles to attach it to.
7. No vehicles are to be parked on Historical Society property. You may drive your vehicle to the pavilion to load and unload.
8. No bon-fires, campfires or fireworks of any type are allowed. Grilles may be used to BBQ.
9. Do not affix tape or other similar substance to any surface in the pavilion. Any items tied to the benches in the pavilion (balloons, etc.), must be removed at the end of the event.
10. No defacing of the picnic tables or the pavilion structure. Defacing is defined as no pencil, pen, crayon, magic marker, paint, knife or sharp instrument used on wooden surfaces or cement floor.
11. Rental time is from **10:00 A.M. to 7:00 P.M.**
12. A Society representative will turn on the electricity and open the Spring House at **10:00 A.M.**
13. Pavilion should be left in the same condition as rented.

**WE RESERVE THE RIGHT TO INQUIRE ABOUT THE NATURE OF THE FUNCTION AND TO REFUSE INAPPROPRIATE ACTIVITIES AND USAGE.**
