#### CITIZENS REQUESTS

MATT DURIK OF 36 NORTH THIRD STREET ASKED ABOUT THE VACANT LOTS IN THE CITY AND HOW THEY CAN BE PUT BACK ON THE TAX ROLLS. HE ALSO ASKED ABOUT FIXING APRICOT ALLEY BETWEEN GRANT AVENUE AND HAMILTON AVENUE. CITY MANAGER FRANK PICCOLINO ADDRESSED THE ISSUES OF THE VACANT LOTS AND EXPLAINED THE PROCESS IT TAKES TO GET THE FUNDING AND REASONS WHY THE CITY DIDN'T GO THROUGH THE COUNTY. THE CITY MANAGER ALSO STATED THAT WE HAVE OUR OWN REDEVELOPMENT AUTHORITY. CODE ENFORCEMENT OFFICIAL ALLAN CHIESI ADDRESSED THE ISSUE OF REPAIRING APRICOT ALLEY SAYING THAT THEY WERE LOOKING INTO WHAT CAN BE DONE TO REPAIR THE STREET.

DAWN OF 1010 ORCHARD PARK VOICED HER CONCERNS ABOUT THE RECREATION CENTER (BOYS & GIRLS CLUB) BY ORCHARD PARK BEING CLOSED. THE CITY MANAGER ADDRESSED THE ISSUE INFORMING HER THAT ALLEGHENY COUNTY HOUSING AUTHORITY (ACHA) OWNS THE PROPERTY AND THAT THEY ARE THE ONES TO TALK TO DUE TO THE FACT THAT THEY ARE THE ONES WHO CAN LEASE OUT THE BUILDING. THE CITY MANAGER ALSO ADDRESSED THE RUMORS OF THE STATE POLICE MOVING INTO THE BUILDING SAYING THAT THEY ARE NOT GOING TO MOVE IN THE BUILDING.

HE ALSO NOTED THAT HE SPOKE TO SOMEONE FROM HOUSING AUTHORITY TELLING THEM THAT THEY (STATE POLICE) ARE NOT TO MOVE IN THERE.

#### CITIZENS REQUESTS

ANDY VAMOS OF 1110 KARL AVENUE WOULD LIKE TO COMMEND THE STREET DEPT. FOR A JOB WELL DONE. MR VAMOS STATED THAT THE RESIDENTS ON KARL AVE HAS TOLD HIM SEVERAL TIMES HOW GOOD THE STREET DEPT HAS DONE WITH THEIR STREET AND WANTED TO THANK THEM. MR VAMOS STATED THAT THE RESIDENTS ON KARL STREET WANTED HIM TO RELAY THE MESSAGE AT THE COUNCIL MEETING. MR VAMOS ALSO WANTS TO GIVE THANKS TO OUR FIRE AND POLICE DEPTS. AND TO WISH THEM WELL ON THEIR EVERYDAY DUTIES. HE CONTINUES TO SAY THE THINGS HE SEE ON THE NEWS IS TERRIBLE AND THAT HE TAKES HIS HAT OFF TO OUR POLICE AND FIRE DEPTS TO SAY THANKS AGAIN.

NICKOLE NESBY OF 513 COCHRAN STREET STATED THAT SHE'S BEEN TALKING WITH SEN. BREWSTER'S OFFICE AND WAS TOLD THAT THEY'RE IN THE PROCESS OF SECURING \$3 MILLION DOLLARS TO EXPAND AMERICAN TEXTILE. SHE THINKS THAT'S A GREAT IDEA FOR THE COMMUNITY.

THEY'RE A LARGE STAPLE HERE WHICH HAS APPROXIMATELY 250 EMPLOYEES. SHE ASKS HOW MANY OF THOSE EMPLOYEES ARE ACTUALLY RESIDENTS OF THE CITY OF DUQUESNE? SHE STATES THAT IT IS HER UNDERSTANDING THAT OUR POPULATION CONSIST OF APPROXIMATELY 80% OF OUR COMMUNITY ARE BENEFIT RECEPIENTS AND THAT 40% HAVE CRIMINAL BACKGROUNDS. SHE ALSO SAYS THAT IT HAS BEEN BROUGHT TO HER ATTENTION THAT AMERICAN TEXTILES HIRES THROUGH A TEMP AGENCY, ALLOWS THE EMPLOYEE TO WORK BUT WHEN ELIGIBLE FOR FULL TIME HIRE THE FACT THAT THE EMPLOYEE HAS A CRIMINAL BACKGROUND COMES UP, IN TURN MAKES THEM INELIGIBLE FOR HIRING. SO SHE WOULD LIKE TO KNOW DO WE HAVE ANY OF THOSE STATISTICS OR INFORMATION BEFORE HAND BEFORE WE CONSIDER GOING FORWARD WITH AWARDING \$3 MILLION FOR THEM TO EXPAND. CITY MANAGER FRANK PICCOLINO STATED THAT THE \$3 MILLION DOLLARS WAS NEWS TO US. THEY HAVEN'T APPROACHED US FOR A BUILDING PERMIT, WITH PRELIMINARY SITE PLANNING OR ANYTHING LIKE THAT, BUT AS FAR AS HOW MANY PEOPLE WORK THERE FROM DUQUESNE OR THE PROCESS THAT WAS MENTIONED. CITY MANAGER FRANK PICCOLINO STATED THAT HE DIDIN'T KNOW ANYTHING ABOUT IT. HE ALSO SAID THAT AMERICAN TEXTILES IS A PRIVATE COMPANY. HE BELIEVES THAT IF YOUR'RE TIED INTO SOME TYPE OF PUBLIC FUNDING, THERE IS AN EMPLOYMENT HIRING PROCESS. HE ALSO STATED THAT HE'S NOT SURE IF IT'S LEGAL TO ACQUIRE THAT INFORMATION. MS NESBY STATED THAT THE \$3 MILLION DOLLARS CAN POSSIBLY BENEFIT THE OTHER SIDE OF THE RAILROAD TRACKS (RIDC AREA) WHERE WE ARE HAVING ISSUES WITH OUR WATER, WHERE WE ARE HAVING PROBLEMS WITH OUR INFASTRUCTURE AND OUR STREETS OR PERHAPS WE CAN BUILD SOME AFFORDABLE HOUSING DOWN THERE. THE CITY MANAGER STATED THAT HE IMAGINES THAT THERE A IS SEPARATE PROGRAM FOR THAT USE. MS NESBY STATED THAT SHE CAN CALL ABOUT THAT BUT ALSO STATED THAT IT'S FOR DEVELOPMENT AND SHE CERTAINLY HOPES THAT THE CITY CAN FIND SOMETHING ELSE USEFUL WITH IT IF THEY DON'T HAVE A LARGE NUMBER OF EMPLOYEES FROM THE CITY ACTUALLY WORKING THERE. MR PICCOLINO STATED THAT HE DOESN'T KNOW IF YOU CAN MANDATE THEM TO HIRE CITY RESIDENTS TO BE EMPLOYED. THERE MIGHT BE A STIPULATION THAT IF YOU GET PUBLIC FUNDING, YOU HAVE TO HIRE FIRST BUT HE'S SAID THAT HE'S NOT GOING TO PROMISE THAT'S WHAT IT IS, HE SAID HE HEARD FROM DIFFERENT DEALS THAT IF YOU GET A TAX CREDIT THAT YOU HAVE HIRE DUQUESNE RESIDENTS FIRST AND THAT KEEPS YOUR TAX CREDIT GOOD. MS NESBY ASKED IF THERE IS A WAY SOME TYPE OF MEETING CAN BE SETUP SO THAT A DISCUSSION ABOUT THE USAGE OF TEMP AGENCIES TO HIRE FOR AMERICAN TEXTILES CAN BE ADDRESSED.

MS NESBY'S NEXT QUESTION WAS FOR REV CALDWELL WANTING TO KNOW IF HE HAS RECEIVED ANY UPDATED INFORMATION REGARDING YOUTH PLACES. REV CALDWELL RESPONDED SAYING NO HE HAS NOT RECEIVED

ANY UPDATED INFORMATION FROM YOUTH PLACES AS OF YET BUT SAID THAT HE WILL BE IN TOUCH WITH 2 OF THEIR TOP PEOPLE TOMORROW AND THAT HE CAN HAVE INFORMATION ON THAT BY FRIDAY. HE ALSO TOLD MS NESBY THAT HE HAS THE INFORMATION WHERE THERE IS APPLICATIONS FOR THE HABITAT FOR HUMANITY TO WHERE PEOPLE WOULD BE ABLE TO SIGN THAT APPLICATION AND THEY CAN BE PUT ON A LIST TO RECEIVE THE HOUSING. MS NESBY ASKS THAT WHEN HE RECEIVES THAT INFORMATION ON FRIDAY CAN HE PROVIDE BOTH HER AND FRANK WITH THAT SAME INFORMATION. SHE ALSO WANTS TO KNOW FROM CITY MANAGER FRANK PICCOLINO IF THE CITY WOULD CONSIDER SENDING A LETTER TO YOUTH PLACES. GENERALLY WHEN FUNDING IS GRANTED TO A NON PROFIT ORGANIZATION. IT'S DONE IN 3 -5 INCREMENTS. YOUTH PLACES IS STILL SUPPOSE TO SERVICE THE RESIDENTS OF THE CITY OF DUQUESNE, OUR CHILDREN AGES 12-18 AND THEY ARE NOT. SHE WANTS TO KNOW WHERE EVER THE FUNDING CAME FROM, CAN THE CITY SEND A LETTER TO THEM TO CEASE AND DESIST BECAUSE THEY ARE NO LONGER PROVIDING SERVICES IN OUR AREA. MR PICCOLINO STATED THAT THEY LEFT THE BOYS N GIRLS CLUB. MS NESBY AGREED WITH MR PICCOLINO ABOUT YOUTH PLACES VACTING THE BOYS N GIRLS CLUB BY THE ORCHARD PARK APARTMENTS. SHE ALSO SAID THAT YOUTH PLACES STILL RECEIVED FUNDING. SHE'S UNSURE OF WHO THEIR FUNDING PROVIDER WAS, BUT AGAIN STATED THAT YOUTH PLACES HAS ALREADY BEEN COMPENSATED FINANCIALLY FOR PROVIDING SERVICES IN OUR CITY AND THEY'RE NOT.

MS NESBY IS ALSO ASKING THAT SOMETHING BE DONE ABOUT THE WHITE PICK UP TRUCK THAT'S PARKED ON HER HILLSIDE ACROSS FROM HER RESIDENCE. SHE SAID THAT IT HAS BEEN THERE FOR OVER THREE WEEKS AND WANTS TO KNOW IF SOMEONE CAN TALK TO THE OWNER TO FIND OUT WHY. SHE WAS TOLD BY MY GYURE TO TALK TO THE CHIEF OF POLICE WHO TAKES CARE OF THE CARS. CHIEF ADAMS ASKED WHERE THE LOCATION OF THE VEHICLE WAS AND THAT HE WOULD PASS THE INFORMATION ALONG TO SGT. SHAW WHO HANDLES THE ABANDONED CARS.

MS NESBY THEN WENT BACK TO THE ISSUES ON AMERICAN TEXTILES WANTING TO KNOW WHAT TYPE OF TAX CREDIT IF ANY THEY MIGHT HAVE RECEIVED TO DO BUSINESS IN THE CITY OF DUQUESNE. MR PICCOLINO STATED THAT AS FAR AS HE KNOWS THERE WASN'T ANY TAX CREDIT GIVEN BUT NOTED THAT THE DEAL WAS PUT IN PLACE BEFORE HE WAS EMPLOYED BY THE CITY OF DUQUESNE. HE STATED HE BELIEVES AMERICAN TEXTILE RECEIVED A NO INTEREST LOAN THROUGH THE STATE.

MATT DURIK OF 36 NORTH THIRD STREET STATED THAT HE HAS A COUPLE OF QUESTIONS. HE ASKED THE CODE ENFORCEMENT OFFICIAL ALLAN CHIESI IF THERE WERE ANY ORDINANCES ON NUISANCE PROPERTIES. HE SAID UNDER THE LCB CRITERIA HE WAS WONDERING IF THERE WERE ANY ORDINANCES LIKE HOMES WITH LOUD MUSIC, EXCESSIVE POLICE CALLS

AND PEOPLE WHO HAVEN'T ADAPTED TO SOCIETY MORE OR LESS. CODE ENFORCEMENT OFFICIAL ALLAN CHIESI STATED THAT TO HIS KNOWLEDGE THERE AREN'T ANY ORDINANCES TO THAT EXTENT OTHER THAN LOUD NOISE OR THE DAY TO DAY THINGS POLICE DEAL WITH. MR DURIK SAID THE REASON HE ASKED WAS BECAUSE DUQUESNE HAS A HIGH POPULATION OF RENTAL PROPERTIES AND TO SEE IF THERE WAS AN ORDINANCE STATING THAT A LANDLORD CAN BE FINED IF HIS / HER TENANT IS CAUSING A DISTURBANCE IN THE NEIGHBORHOOD. MR CHEISI STATED THERE'S NO ORDINANCE TO HIS KNOWLEDGRE THAT SPEAKS TO THIS ISSUE AT THIS TIME. MR DURIK ADDRESSES CITY MANAGER FRANK PICCOLINO SAYING THE LAST TIME THEY SPOKE MR DURIK SAID THAT HE DID PUT IN APPLICATION IN WITH THE COUNTY FOR THE VACANT LOT PROGRAM, HE ASKED MR PICCOLINO WAS HE ABLE TO FIND OUT BY FILLING THAT APPLICATION WITH THE COUNTY, WHAT WERE THE REQUIREMENTS AS A CITY. MR PICCOLINO ANSWERED WITH JUST A SIMPLE OFF / END RESOULTION, WHICH WON'T BE UNTIL JUNE / JULY BECAUSE THAT'S THEIR FISCAL YEAR. THEN YOU'LL GO THROUGH THE COUNTY TO APPLY FOR THE VACANT LOT PROGRAM. YOU USE THEIR APPLICATION THEY PROVIDE ON LINE AND COMPLETE IT WITH THE INFORMATION OF THE VACANT LOT. THEN IT'S UP TO THE COUNTY TO DETERMINE WHAT FUNDING, WHO GETS FUNDING AND WHAT SITES GET FUNDING. MR DURIK ASKS ONCE THIS GOES INTO AFFECT YOU APPLY WITH THE COUNTY AND WRITE A LETTER SAYING WHAT YOUR PLANS ARE WITH THAT PIECE OF PROPERTY. MR PICCOLINO NOTED THAT'S ON THE PERSON WHO WANTS THE LOT NOT THE CITY, MR DURIK ADDRESSES THE ACT 47 COORDINATOR JONATHAN INGRAM ON THE 2014- 2017 RECOVERY PLAN SAYING AFTER READING OVER IT HE WAS JUST CURIOUS TO FIND OUT THAT ONE OF THE RECOMMENDATION TO GET OUT OF THE ACT 47 WAS TO FORM A DIRECTORY OF BUSINESSES AND RESIDENCES OF THE CITY, HAS THAT BEEN DONE YET? MR INGRAM ANSWERED NO. MR DURIK STATES ACCORDING TO 2014-2017 RECOVERY PLAN (PAGE 35) ONE OF THE REQUIREMENTS / RECOMMENDATIONS SAID THAT THE CITY SHOULD CONDUCT A DIRECTORY OF ALL BUSINESSES AND HOME OWNERS OF THE CITY TO FIND OUT WHO OWNS THEM, WHO OWES BACK TAXES. WHO WE GO AFTER, ETC. MR DURIK ASKS MR INGRAM IF HE KNOWS IF THIS STEP HAS TAKEN PLACE. MR INGRAM ANSWERS STATING WHAT THAT IS, IS A BROADER POTENETIAL IMPLEMENTATION STEP TO TRY TO DRAW IN MORE COMMUNITY TAX. MR INGRAM STATES THAT IT'S AN ONGOING EFFORT AND ONGOING CHALLENGE AS WELL DUE TO THE FACT PROPERTY CHANGES HANDS. MR DURIKS ALSO ASKS THAT SINCE WE'RE UNDER THE ACT 47 WE'RE ELIGIBLE FOR GRANT MONEY, HAS THE CITY EVER GONE AFTER ANY OF THAT GRANT MONEY. CITY MANAGER FRANK PICCOLINO ANSEWRS SAYING THAT WE GO AFTER AS MUCH GRANT MONEY AS WE CAN. HE CONTINES TO SAY THAT THERE ISN'T A SET LINE OF GRANTS TO APPLY FOR, IT'S MORE LIKE YOU PUT IN A PREFERENCE SO WHENEVER THEY COME ABOUT WE DO DCNR GRANTS, DCED GRANTS, CITF GRANTS WHICH WE'VE BEEN SUCCESSFUL AND CDBG IS UNDER THE FEDERAL GOVT.

SO AS LONG AS WE'RE IN ACT 47 WE GET SPECIAL ALLOTMENT AND THAT'S FOR STREET, WATERLINES AND THINGS OF THE SORT. IT DOES ACTUALLY HELPS US. IF WE'RE OUT OF IT OUR CDBG FUNDING GETS CUT BY ABOUT TWO-THIRDS. MR DURIK ALSO STATES THAT ANOTHER RECOMMENDATION WAS TO CHANGE TO THE OPTION OF THE HOME RULE CHARTER OPTIONAL PLAN 72 ACT 62. HE ASKS DID WE HAPPEN TO DO THAT OR ARE WE STILL UNDER THE OPTION OF THE THIRD CLASS CITY CHARTER LAW 1957 ACT. CITY MANAGER FRANK PICCOLINO ANSWERS STILL UNDER THE CURRENT FORMAT.

KEVIN PRICE OF 301 SOUTH FOURTH STREET ASKS HOW OFTEN WE WRITE GRANTS HERE. HE CONTINUES TO SAY THAT HE KNOWS MONEY IS ALLOCATED THROUGH THE GOVT AND THINGS LIKE THAT FOR GRANTS. HE ALSO STATES THAT WE CAN USE GRANTS HERE IN THE CITY FOR RECREATIONAL PROGRAMS AND SUMMER WORK FOR THE KIDS SO THEY WON'T HAVE SO MUCH TIME ON THEIR HANDS. IT USED TO BE WHERE THE CITY WAS INVOLVED WITH GETTING GRANTS TO HAVE PROGRAMS SO WE CAN GET THESE KIDS MOTIVATED. HE SAID AT TIMES IN THE SUMMER HE IS SEEING 10-20 KIDS HANGING AROUND TOGETHER WITH NOTHING TO DO. HE SAYS THAT THEY CAN'T GO TO THE BOYS & GIRLS CLUB OR PLACES LIKE THAT. HE STATES THAT HE WOULD LIKE TO SEE THE CITY REALLY APPLY FOR GRANTS AND THINGS. CITY MANAGER FRANK PICCOLINO ADDRESSES MR PRICE BY SAYING THAT THE CITY HAD 10 YOUTHS LAST YEAR THAT WAS SUPPLIED TO US THROUGH AURBERLE, GOODWILL AND PHASE 4. THE CITY MANAGER CONTINUES TO SAY THAT IT WAS A VERY SUCCESSFUL PROGRAM AND THERE WAS NO NEED TO WRITE A GRANT STATEMENT WHEN THEY WERE ALLOCATED THROUGH THE COUNTY AND THE COUNTY DISTRIBUTES FROM THERE. MR PRICE ASKS HOW DO THEY TELL THEM. THE CITY MANAGER STATES THAT HE'S NOT SURE HOW THEY DO THEIR ADVERTISING SAYING THAT HE KNOWS GOOWILL AND AURBERLE DOES THEIR OWN AND PHASE 4 MUST DO THEIR OWN. THE ORGANIZATIONS REACH OUT TO DISTRICTS, PROBABLY WITH SCHOOL DISTRICTS FIRST. THE CITY MANAGER INFORMS MR PRICE THAT ALL THE ADVERTISING IS DONE BY THE ORGANIZATIONS THROUGH THE DISTRICTS THEY CONTACT. HE BELIEVES THAT THEY CHOOSE THE CHILDREN THAT ARE BETWEEN THE AGES OF 14-18. THE ORGANIZATIONS PLACES THE KIDS IN THE AREAS TO WORK EVEN IF IT'S NOT IN THE CITY WHERE THEY RESIDE. MR PRICE ASKS HOW CAN HE FOUND OUT THE INFORMATION. THE CITY MANAGER TELLS MR PRICE THAT HE CAN GET HIM THE INFORMATION HE NEEDS.

THE PENNSYLVANIA DEPT. OF HEALTH IS JUST NOW ACCEPTING APPLICATIONS FOR INDIVIDUALS AND BUSINESSES WHO ARE INTERESTED IN GROWING, PROCESSING AND DISPENSING MEDICAL MARIJUANA, NOW JUST TO BE CLEAR THIS IS MARIJUANA SOLELY FOR MEDICAL PURPOSES, SERIOUS HEALTH CONDITIONS, EPILEPSY. PARKINSONS, TERMINAL CANCER, AND HIV AIDS. IT IS A VERY SPECIALIZED BUSINESS. THERE IS A COMPANY CALLED PURE KEYSTONE WHO IS INTERESTED IN BUILDING A GROWING AND PROCESSING FACILITY IN DUOUESNE. DUE TO DUOUESNE'S STATUS AS AN ACT 47 MUNICIPALITY, PUTTING A FACILITY HERE GIVES THIS COMPANY ESSENTIALLY EXTRA POINTS GOING TOWARDS HOPEFULLY GETTING THEIR APPLICATION ACCEPTED AND A PERMIT ISSUED TO THEM BY THE DEPT. OF HEALTH. NOW THE REASON FOR THAT OF COURSE IS THAT THERE IS GOING TO BE INCREASED TAX MONEY THAT WOULD BE GENERATED TO THE CITY IF THIS FACILITY WAS BUILT HERE. PURE KEYSTONE HAS ALREADY MET WITH CITY MANAGER FRANK PICCOLINO AND MAYOR KRIVACEK AND ARE PUTTING THEIR APPLICATION TOGETHER NOW. THEY ARE LOOKING TO PUT THEIR FACILITY ON A PORTION OF SOUTH LINDEN STREET, WHICH IS IN THE CITY CENTER DISTRICT (CCD). THIS WOULD BE AN ACCEPTABLE AREA FOR THE FACILITY AS FAR AS OUR ZONING ORDINANCES GO. NOW WHAT'S GOING TO HAPPEN FROM HERE ON OUT IS THAT THEIR APPLICATION IS DUE ON

MARCH 20. WE HAVE NOTHING TO DO WITH THEIR APPLICATION PROCESS, HOWEVER THEY HAVE COMMUNICATED THEIR ABILITY AND DESIRE TO PAY TO DUQUESNE A HOST FEE. THIS IS ALSO KNOWN AS AN IMPACT FEE. NOW SOMETIMES IN AREAS THAT ARE SORT OF UP AND COMING, A BUSINESS CAN OFFER TO PAY A HOST OR IMAPCT FEE. WHAT THAT MEANS IS THAT A PERCENTAGE (SMALL PERCENTAGE) OF THEIR GROSS REVENUE WOULD GO TO DUQUESNE AND THEN THE CITY CAN SET UP A CAPITAL FUND, AN ACCOUNT THAT CAN BE USED FOR IMPROVEMENTS AND THINGS OF THAT NATURE. WE ARE VERY FAR AT THIS POINT FROM NEGOTIATING THAT ACTUAL AGREEMENT WITH THEM BECAUSE OF COURSE THEY DON'T EVEN HAVE A PERMIT YET. THEY ARE STILL IN THE EARLY STAGES. HOWEVER AT THIS POINT I WOULD LIKE TO RECOMMEND THAT A MOTION BE MADE TO ALLOW CITY MANAGER FRANK PICCOLINO AND MAYOR KRIVECEK TO PARTICIPATE IN EARLY NEGOTIATIONS TO HOPEFULLY GET ONE OF THESE AGREEMENTS IN THE WORKS, SHOULD PURE KEYSTONE ACTUALLY RECEIVE A PERMIT FROM THE DEPARTMENT. MOTION WAS MADE BY MR GYURE AND SECONDED BY MS WILSON. CARRIED 3-0.

DAVID GILLILAND: BIDS WERE OPENED ON FEBRUARY 15 FOR 3 PROJECTS IN THE CITY: AURILLES STREET WATERLINE REPLACEMENT, REPLACEMENT OF THE WATER VALVE AT FIRST STREET AND GRANT AVENUE AND WIRELESS MODEMS FOR WATER SYSTEM CONTROLLERS. THERE WERE NO BIDS RECEIVED FOR THE WIRELESS MODEMS. IT IS MY RECOMMENDATION THAT THE CITY AUTHORIZE US TO REASSESS PROPOSALS FOR THAT, IN FACT BE TAKEN OUT THE CD PROGRAM. MOTION MADE BY MR GYURE AND SECONDED BY MS WILSON. CARRIED 3-0.

THIS FREES UP \$15,000 IN GRANT MONEY WHICH WE'LL BE NEEDING ON THE LAST ITEM OF THE ORDER.

SECOND ITEM IS THE WATER VALVE REPLACEMENT AT FIRST STREET AND GRANT AVENUE FOR \$20,000. THE LOW BID WAS FROM NEVAEH PIPE BURTSING IN THE AMOUNT \$7,300. IT IS MY RECOMMENDATION THAT COUNCIL AUTHORIZES SRCOG TO AWARD THE WATER VAVLE REPLACEMENT PROJECT TO NEVAEH PIPE BURSTING FOR \$7,300. MOTION MADE MY GYURE AND SECONDED BY REV CALDWELL. CARRIED 3-0.

THAT GRANT WAS FOR \$20,000 SO THERE IS A SIGNIFICANT SAVINGS THERE.

THE THIRD BID WAS FOR THE CD 42 AURILLES STREET WATERLINE. THE LOW BID WAS FROM AGAIN THE NEVAEH PIPE BURSTING FOR \$195,938. THE GRANT FOR THAT PROJECT WAS ONLY FOR \$167,980, HOWEVER SINCE WE ARE NOT DOING THE CONTROLLERS WE CAN TRANSFER THE \$15,000 TO THAT AND THE EXCESS MONEY FROM THE WATER VALVE

REPLACEMENT. WHEN WE DO THAT, THE COUNTY HAS TO OFFICIALLY APPROVE THE TRANSFER AND THEN THAT ONLY LEAVES THE CITY A BALANCE OF \$258.00. MOTION NEEDED TO AUTHORIZE SRCOG TO AWARD CD 42 AURILLES STREET WATER LINE PROJECT TO NEVAEH PIPE BURSTING FOR \$195,938 CONTINGENT UPON THE TRANSFER OF FUNDING BY ALLEGHENY COUNTY WAS MADE BY MR GYURE AND MS WILSON. CARRIED 3-0.
