JDANCE STUDIO POLICIES AND RULES

- **ENROLMENT FEES.** A NON-REFUNDABLE REGISTRATION IS DUE EACH JANUARY, AND WHEN THREE (3) MONTHS OR MORE HAS ELAPSED BETWEEN ATTENDANCES OF CLASSES.
- **DEPOSIT.** A NON-REFUNDABLE DEPOSIT OF \$10 PER CLASS (max\$50) APPLIES TO SECURE A POSITION. THIS IS DEDUCTED FROM THE TERM FEES.
- **ENROLMENT.** ENROLMENT IS FOR THE WHOLE YEAR AND IS INVOICED PER NSW GOVERNMENT SCHOOL TERMS. AS ENROLMENTS ARE FOR THE ENTIRE YEAR, **ANY STUDENT NOT RETURNING FOR THE FOLLOWING TERM OR MID-TERM, MUST GIVE THE REQUIRED 4 WEEKS WRITTEN NOTICE BY FILLING OUT OUR “WITHDRAWAL REQUEST FORM” AND SUBMITTING TO OFFICE (OR SEND EMAIL), OR FUTURE FEES WILL STILL BE INVOICED AND CHARGED AND ARE DUE AND PAYABLE.**
- **TERM FEES INVOICE.** FEE INVOICES ARE ISSUED IN THE FIRST WEEK OF EACH TERM AND ARE DUE AND PAYABLE WITHIN 4 WEEKS, EXCEPT TERM ONE WHERE FEES ARE DUE WITHIN 5 WEEKS. NO REBATES FOR MISSED CLASSES.
- **FEES DISCOUNTS.** SOME FEES ARE DISCOUNTED, BUT THE DISCOUNT ONLY APPLIES IF STUDENTS REMAIN ENROLLED FOR ALL OF THE DANCE YEAR AND IF THE FULL FEES ARE PAID BY THE DUE DATE, OTHERWISE A NEW INVOICE WILL BE ISSUED WITHOUT ANY DISCOUNT.
- **LATE PAYMENT FEE.** A 10% ADMINISTRATION FEE WILL BE CHARGED ON ALL FEES PAID AFTER THE DUE DATE.
- **DEBT COLLECTION.** EXTREMELY OVERDUE FEES WILL BE PLACED IN THE HANDS OF A COLLECTION AGENCY FOR RECOVERY PLUS LEGAL COSTS, UNLESS PAYMENT ARRANGEMENTS HAVE BEEN MADE AND ABIDED BY.
- **DANCE TERMS.** ALL DANCE TERMS FOLLOW NSW GOVERNMENT SCHOOLS INCLUDING NSW PUBLIC HOLIDAYS. ALL DANCE CLASSES ARE HELD ON “PUPIL FREE SCHOOL DAYS”.

JDANCE STUDIO POLICIES AND RULES

- **ENROLMENT FEES.** A NON-REFUNDABLE REGISTRATION IS DUE EACH JANUARY, AND WHEN THREE (3) MONTHS OR MORE HAS ELAPSED BETWEEN ATTENDANCES OF CLASSES.
- **DEPOSIT.** A NON-REFUNDABLE DEPOSIT OF \$10 PER CLASS (max\$50) APPLIES TO SECURE A POSITION. THIS IS DEDUCTED FROM THE TERM FEES.
- **ENROLMENT.** ENROLMENT IS FOR THE WHOLE YEAR AND IS INVOICED PER NSW GOVERNMENT SCHOOL TERMS. AS ENROLMENT IS FOR THE ENTIRE YEAR, **ANY STUDENT NOT RETURNING FOR THE FOLLOWING TERM OR MID-TERM, MUST GIVE 4 WEEKS WRITTEN NOTICE BY FILLING OUT OUR "WITHDRAWAL REQUEST FORM", OR FUTURE FEES WILL STILL BE INVOICED AND CHARGED AND ARE DUE AND PAYABLE.**
- **TERM FEES INVOICE.** FEE INVOICES ARE ISSUED IN THE FIRST WEEK OF EACH TERM AND ARE DUE AND PAYABLE WITHIN 4 WEEKS.
- **FEES DISCOUNTS.** SOME FEES ARE DISCOUNTED, **THE DISCOUNT ONLY APPLIES IF STUDENTS REMAIN ENROLLED FOR ALL OF THE DANCE YEAR AND IF THE FULL FEES ARE PAID BY THE DUE DATE, OTHERWISE A NEW INVOICE WILL BE ISSUED WITHOUT ANY DISCOUNT.**
- **LATE PAYMENT FEE.** A 10% ADMINISTRATION FEE WILL BE CHARGED ON ALL FEES PAID AFTER THE DUE DATE.
- **DEBT COLLECTION.** EXTREMELY OVERDUE FEES WILL BE PLACED IN THE HANDS OF A COLLECTION AGENCY FOR RECOVERY PLUS LEGAL COSTS, UNLESS PAYMENT ARRANGEMENTS HAVE BEEN MADE AND ABIDED BY.
- **DANCE TERMS.** DANCE TERMS FOLLOW NSW GOVERNMENT SCHOOLS AND NSW PUBLIC HOLIDAYS. CLASSES ARE HELD ON "PUPIL FREE DAYS".
- A \$10 ADMINISTRATION FEE IS CHARGED FOR A REPRINT OF INVOICES AND OR ANY CHANGES TO INVOICES, DELETING CLASSES..
- I AGREE THAT TEACHERS & STAFF AT JDANCE PERFORMANCE STUDIO ARE NOT RESPONSIBLE FOR MY CHILD OUTSIDE THE CLASS AND UNDERSTAND THERE IS NO FULL TIME SUPERVISION OUTSIDE THE CLASS. I AM AWARE OF THE INHERENT RISKS IN LEAVING MY CHILD UNATTENDED/UNSUPERVISED OUTSIDE OF CLASS TIMES ENROLLED.
- DANCERS SHOULD BE ON TIME FOR CLASS AND BROUGHT INTO THE BUILDING BY A PARENT OR GUARDIAN. AS A COURTESY, PLEASE SEND A TEXT TO MISS JENNY 0409 532 623 SHOULD YOUR CHILD BE ABSENT FROM CLASSES.
- JDANCE UNIFORMS ARE REQUIRED, INCLUDING APPROPRIATE FOOTWEAR.
- NOISE MUST BE MINIMAL UPON ARRIVAL AND DEPARTURE AT CLASSES.
- NO PARKING IN UNAUTHORIZED AREAS. THE SHOPS IN FRONT OF THE STUDIOS HAVE A 15 MINUTE PARKING LIMIT AND SHOULD BE USED FOR DROP OFF AND PICK UP ONLY. **THE DRIVEWAY MUST NOT BE ENTERED BY ANY VEHICLES AT ANY TIME** DUE TO STUDENTS SAFETY.
- JDANCE DOES NOT PERMIT NON-DANCERS IN THE STUDIO DURING CLASSES. A VIEWING DAY IS HELD ON THE 2ND LAST WEEK OF TERM 1, 2 & 3 ONLY. NEWCOMERS ARE WELCOME TO VIEW CLASSES UPON REQUEST.
- PAYMENTS MAY BE MADE BY INTERNET BANKING, CHEQUE OR CASH.
- THERE ARE NO REBATES FOR MISSED CLASSES. PROVIDED THERE IS A VACANCY, STUDENTS CAN DO A MAKE-UP CLASS WITHIN THE SAME TERM.
- TO PRESERVE THE INTELLECTUAL PROPERTY OF OUR CREATIVE TEACHERS, ALL CHOREOGRAPHY TAUGHT BY JDANCE PERFORMANCE STUDIO TEACHERS AND CONTRACT TEACHERS REMAINS THE PROPERTY OF JDANCE PERFORMANCE STUDIO AND MAY NOT BE USED WITHOUT PERMISSION.
- PARENTS ARE RESPONSIBLE FOR MAINTAINING UP TO DATE CONTACT DETAILS.
- IT IS THE STUDENT'S RESPONSIBILITY TO NOTIFY THEIR TEACHER IN THE EVENT OF INJURY/MEDICAL CONDITION DURING OR PRIOR TO CLASS
- **CHEWING GUM AND SMOKING IS STRICTLY PROHIBITED** ON THE PREMISES! NO FOOD OR DRINKS OTHER THAN BOTTLED WATER ARE PERMITTED IN THE UPSTAIRS STUDIOS.

- JDANCE IS NOT RESPONSIBLE FOR MISPLACED, LOST OR STOLEN PERSONAL ITEMS.
- **PLEASE DO NOT WEAR DANCE SHOES OUTDOORS!** PLEASE USE A SEPARATE PAIR OF SHOES FOR WALKING OUTDOORS. HELP US KEEP OUR STUDIO FLOORS IN GOOD CONDITION BY OBSERVING THESE REQUIREMENTS.
- PLEASE AVOID GOSSIP THAT MAY SPREAD MISINFORMATION. IF YOU NEED TO DISCUSS A SITUATION, PLEASE CALL JENNY TO ARRANGE A MUTUALLY CONVENIENT MEETING TIME.
- **WHILST YOUR CHILD IS ATTENDING JDANCE, HE/SHE SHOULD NOT PARTAKE IN PERFORMING ARTS TUITION AT ANY OTHER INSTITUTION WITHOUT PRIOR PERMISSION FROM MISS JENNY, AS THIS COULD BE A CONFLICT OF INTEREST AND DETRIMENTAL TO THEIR TRAINING.**

IF PARENTS HAVE CONCERNS ABOUT ANYTHING TO DO WITH THEIR CHILD'S PLACEMENT, PROGRESS OR ANY OTHER ASPECT OF THEIR INVOLVEMENT AT JDANCE, YOU ARE ENCOURAGED TO CONTACT JENNY AND ARRANGE A MEETING TO DISCUSS IT. JDANCE PERFORMANCE STUDIO IS A PROFESSIONAL AND WELL MANAGED DANCE STUDIO. WE PRIDE OURSELVES ON OUR PERSONAL YET PROFESSIONAL RELATIONSHIP WITH ALL OF THE FAMILIES WE WORK WITH.
