Optional setup and knockdown services are available for an additional 20% of equipment cost per service.

**DELIVERY POLICY:** All delivery charges are for "standard" garage, front or backyard, truck accessible property and/or 1st floor businesses. Additional charges can/will occur for "abnormal, difficult or time consuming" delivery locations.
