Sealed proposals will be received by the Borough of North Caldwell, New Jersey at the Borough Hall, 141 Gould Avenue, North Caldwell, New Jersey 07006, on Tuesday, July 2, 2019 at 9:00 a.m., prevailing time, and then publicly opened and read aloud for:

**FURNISHING REGULAR UNLEADED MOTOR FUEL GASOLINE  
AND DIESEL FUEL**

Copies of the Specifications are on file and open to public inspection at the North Caldwell Borough Hall, 141 Gould Avenue, North Caldwell, New Jersey 07006, and may be examined and obtained by properly qualified vendors during regular business hours (8:30 a.m. to 4:30 p.m.). Bidders will be furnished with a copy of the Specifications by the Borough Clerk upon request.

Each proposal shall be made upon the prescribed forms furnished with the Contract Specifications and will be accompanied by a certified check, cashier's check or bid bond in the sum of ten percent (10%) of the amount of the bid or \$20,000.00 whichever is less. Checks will be made payable to the Borough of North Caldwell. Bid Security will be held as a guarantee that in the event the bid is accepted and a Contract awarded to the bidder, the Contract will be duly executed, and in default thereof, said Bid Security and the amount represented thereby will be forfeited to the aforesaid Borough of North Caldwell as liquidated damages.

Proposals shall be accompanied, in the case of corporations not chartered in New Jersey, by property certificate that such corporation is authorized to do business in the State of New Jersey.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27-1 et seq.

Each proposal will be enclosed in a sealed envelope bearing the name and address of the bidder, will be addressed to the Borough of North Caldwell, New Jersey and will be endorsed "Bid for Furnishing Regular Unleaded Motor Fuel Gasoline and Diesel Fuel".

The Borough of North Caldwell reserves the right to reject any and all bids, to waive any minor informalities or irregularities in the bids received, and to accept the bid which in its judgment best serves the interests of the Borough.

## CONDITIONS

Each bidder must strictly comply with all requirements for regular bids as directed or required by this notice, the statutes in such cases made and provided, and the specifications. Notice is hereby given to all bidders that if their bids are informal, defective or irregular, the same will be immediately rejected.

The successful bidder shall supply gasoline and diesel fuel as requested by authorized Borough of North Caldwell employees in accordance with procedures to be established.

The following items shall be part of the basic contract for services and must be included in the bid

### WITHOUT EXCEPTION:

- \* The successful bidder's gasoline and diesel fuel pumps must be located within three (3) miles of the front door of the Borough of North Caldwell Municipal Building on Gould Avenue, North Caldwell, New Jersey. All purchases will be made at vendor's location.
- \* All gasoline supplies must be 87 Octane or higher unleaded gasoline.
- \* The successful bidder must be able to supply motor fuels 24 hours per day, seven days per week.
- \* The successful bidder must be willing to make special arrangements to fuel Borough vehicles if situations occur which result in fuel rationing and/or restricted hours of operation.
- \* Arrangements must be made to purchase gasoline and diesel fuel on a strictly credit basis. CASH TRANSACTIONS WILL NOT BE PERMITTED. The successful bidder will be paid once a month upon submission of a properly executed Borough voucher and verification of all charges.

Regular unleaded motor fuel gasoline and diesel fuel must conform strictly to specifications and shall be subject to inspection before acceptance.

In case of failure to furnish regular unleaded motor fuel gasoline and diesel fuel hereby specified in accordance with advertisement and this proposal and bid and the agreement affected thereby, the Council of the Borough of North Caldwell may purchase said gasoline elsewhere and deduct the cost and damages from moneys due or to grow due from said successful bidder.

Where two or more bidders are tied on an item, the Council reserves the right to make the award to one of the tie bidders.

## **CONDITIONS (continued)**

Notice is hereby given that only manufactured products of the United States, wherever available, shall be used in connection with this contract. See Chapter 174, Laws of New Jersey, 19321.

Assignment to any third party of any moneys due or to grow due the bidder on any contract based on this bid is absolutely prohibited and will not be recognized by the Borough; furthermore, should any such assignment of moneys be filed with the Borough, the Borough reserves the right thereafter to refuse all bids from the bidder violating this provision.

This contract will be for a one year period commencing the date of signing.

Bidder will quote on prices less any state and Federal taxes. The Borough of North Caldwell will execute Tax Exemption Certificates with order.

## **INFORMATION TO BIDDERS**

### **B-1 DATE AND PLACE OF OPENING BIDS**

Sealed proposals for this project as described in the Specifications will be received, opened, and read in public at the time and place stated in the advertisement, a copy of which is enclosed herewith. If bids are mailed, they shall be sent certified mail and addressed to: Borough Clerk, 141 Gould Avenue, North Caldwell, New Jersey 07006.

### **B-2 SPECIFICATIONS**

Specifications, form of proposal and contract may be obtained at the office of the Borough Clerk, Borough Hall, 141 Gould Avenue, Borough of North Caldwell, New Jersey or at [www.northcaldwell.org](http://www.northcaldwell.org).

### **B-3 BID SECURITY**

As stated in the advertisement, each bid shall be accompanied by a certified check, cashier's check, or a bid bond to the Borough of North Caldwell in an amount not less than ten percent (10%) of the base bid, but in no case less than \$500.00 nor greater than \$20,000. The checks or bonds of the three lowest bidders will be held by the Borough until the successful bidder is selected, the contract properly executed, and a bond, satisfactory to the Borough, is posted. The checks or bond of all but the three lowest bidders will be returned within three days after the date on which the bids are opened.

The check or bond of the successful bidder shall be forfeited to the Borough as liquidated damages should he fail or refuse to execute and deliver the contract and bond required within ten (10) calendar days after being notified by the Borough that his bid has been accepted.

### **B-4 PREPARATION AND SUBMISSION OF PROPOSALS**

The Borough reserves the right to waive any informalities in the bids or to reject any bid or all bids.

The Proposals shall be made on the forms prepared for that purpose and included herein. All blanks on the Proposal form shall be filled, legibly and in ink or typewritten. No changes in phraseology or qualifying statements will be permitted.

The amount bid for each item shall be obtained by multiplying the unit price bid by the number of units of that item as stated on the Proposal. Should there be an error in the extension, then the unit price shall prevail.

The successful low bidder will be required to furnish documentation, on forms supplied by the Borough, regarding compliance with Federal Affirmative Action requirements.

Each bidder shall submit a manufacturer's specification for the vehicle to be supplied.

### **B-5 DISQUALIFICATION OF BIDDERS**

No person, partnership, firm, corporation, or association shall submit more than one Proposal, either under the same name or under different names. If there are reasonable grounds for believing any bidder is interested in more than one Proposal, then all Proposals in which he is interested shall be rejected. The contract, regardless of bid, will be awarded only to a competent bidder experienced in the class of work to be performed, and equipped, capable, and ready to perform the work.

### **B-6 QUOTED PRICE**

The prices quoted shall hold firm.

### **B-7 EXCEPTIONS/DEVIATIONS**

Any exceptions/deviations to the above Specifications, no matter how small or seemingly minute, must be noted on page ED-1.

### **B-8 COMPLIANCE**

The Mayor and Council reserves the right to determine if any deviations from the minimum Specifications are acceptable and reject or accept any Bids based on such a determination. The bidder proposes to furnish a vehicle and plow in accordance with these Specifications or stated in this bid form. Failure to supply complete information called for on this bid form may render bid as non-responsive.
