

**BOROUGH OF NORTH CALDWELL  
NOTICE TO BIDDERS**

Notice is hereby given that sealed bids will be received by the Borough Administrator of the Borough Of North Caldwell in the County of Essex, State of New Jersey, at the Office of the Borough Administrator, located in the Municipal Building at 141 Gould Avenue, North Caldwell, New Jersey on **Wednesday, September 30, 2020 at 1:30 p.m.**, prevailing time, and at that time and place publicly opened and read for the following:

**Robin Hill Road and Deer Trail Road Improvements**

The work to be performed includes the furnishing of all labor, materials and equipment necessary to complete the work as shown on the drawings and described in the specifications. The work in this contract includes the construction of approximately 17,470 square yards of roadway milling, 2,070 tons of hot mix asphalt pavement, 1,142 lineal feet of Reset Granite Curb, minor drainage improvements and other incidental work.

Plans and specifications and proposal forms are on file and open to public inspection at the Municipal Building, 141 Gould Avenue, North Caldwell, New Jersey 07006 and may be obtained at the office of the Borough Engineer at 180 Main Street, Chester, New Jersey, (908) 879-6209, between the hours of 9:00 am and 5:00 pm, prevailing time, Monday through Friday, excluding legal holidays, starting on September 10, 2020 upon payment of \$50.00, payable to Ferriero Engineering, Inc., said sum will not be refundable.

Sealed bids shall be submitted to the Borough Administrator via Certified mail or overnight delivery, or, alternatively, Bidders are directed to drop their bids through the front door mail slot at Borough Hall. Bidders should call Borough Hall, (973) 228-6410, during regular business hours to schedule a drop-off for oversized bid packages that do not fit through a standard mail slot.

In light of the ongoing Coronavirus Public Health Emergency and the social distancing restrictions enacted by the state of New Jersey in relation to public gatherings, bidders, interested parties and members of the general public will not be permitted to physically attend the unsealing of bids in-person. In order to ensure that bidders, interested parties, and members of the general public who wish to view/attend the live opening of bids on September 30, 2020, at 1:30 p.m., prevailing time, are able to do so, the Borough of North Caldwell will broadcast the unsealing of said bids, in real time, via online livestreaming technology, which the public can access through RingCentral as described below:

At the close of the bid opening on September 30, 2020, the unsealed bid packages of the three (3) lowest apparent bidders will be scanned and posted to the Borough website, <https://www.northcaldwell.org/purchasing>, in order to ensure that bidders, interested parties, and members of the general public are afforded an opportunity to review said bids.

Each bid must be made on the prescribed forms furnished with the Contract Drawings and Specifications, including Proposal Form, Schedule of Prices, Bid Bond Guarantee, Site Inspection Affidavit, Acknowledgment of Receipt of Changes to Bid Documents, Stockholder Statement of Ownership, Non-Collusion Affidavit, Consent to Investigation, Bidder's Qualification Form, NJ Business Registration Certificate, Public Works Contractor Registration Certificate, List of Subcontractors, Plan and Equipment Questionnaire, Disclosure of Investment Activities in Iran, and Bid Opening Checklist.

Bid must be accompanied by a Consent of Surety and a Certified Check, Cashier's Check or Bid Bond of not less than ten (10%) percent of the amount bid, and not to exceed \$20,000.00. Bids may be submitted by mail, but will be considered only if received on or before such date and time.

State of New Jersey Labor prevailing wage regulations and Standards Provisions will apply. Attention is called to the fact that the Contractor must ensure that employees and applicants for employment are not discriminated against because of their age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27, and PL 1977, c.33. Bidders are required to comply with the New Jersey Business Registration Certificate Law, P.L. 2004, c. 57. Bidders are required to comply with the Public Works Contractor Registration Act, P.L. 1999, c. 238.

The Borough reserves the right to reject any and all bids, to waive immaterial informalities, and/or to accept the bid which, in the opinion of the Borough, will be in the best interest of the Borough, all in accordance with the New Jersey Public Contract Law N.J.S.A. 40A:11-1 et. seq.
