ORDINANCE NO. O-1-15

AN ORDINANCE AMENDING CHAPTER 99 OF
THE CODE OF THE BOROUGH OF NORTH
CALDWELL TO REQUIRE PERMIT PARKING
ON HILLSIDE AVENUE

WHEREAS, it appears to the Mayor and Council of the Borough of North Caldwell that the state of parking on Hillside Avenue has become unmanageable for its residents; and

WHEREAS, it has been recommended to the Governing Body by the Chief of Police that a system of permit parking should be established to ensure residents of Hillside Avenue can park within a reasonable distance of their homes; and

WHEREAS, it is the desire of the Mayor and Council of the Borough of North Caldwell to accept this recommendation and put into place permit parking for the residents of Hillside Avenue;

NOW, THEREFORE, BE IT ORDAINED By the Mayor and Council of the Borough of North Caldwell, County of Essex, State of New Jersey as follows:

1. Chapter 99-3. Parking prohibited at all times on certain streets; handicapped parking zones; fire zones; resident permit parking zones, shall be amended to add §99-3D. as follows:

§99-3D(1) The first 100 feet of the south side of Hillside Avenue, starting from the corner of Hillside Avenue and Main Street, and extending to the beginning point of the driveway at the property designated as 707 Main Street, shall be designated as a temporary drop off zone and shall be posted as such;

§99-3D(2) All motor vehicles parking on either side of Hillside Avenue, except in the area referred to in §99-3D(1), must have the requisite permit issued by the Police Department of the Borough of North Caldwell in accordance with the provisions herein;

§99-3D(2)(a) Permits shall only be issued to motor vehicles registered in the State of New Jersey to an address on Hillside Avenue, North Caldwell, New Jersey, with no more than two permits being issued to vehicles registered at any one Hillside Avenue address;

§99-3D(2)(b) All issued permits shall not be transferred between individuals or motor vehicles;

§99-3D(2)(c) Each permit shall be issued to a specific motor vehicle, and must be affixed to the inside rear driver's side window, in a clearly visible location;

§99-3D(2)(d) Should any permitted motor vehicle be sold or transferred, the permit must be removed and returned to the Borough of North Caldwell Police Department within 72 hours

following the sale or transfer;

§99-3D(3) Every person convicted of a violation of this ordinance shall be liable to a penalty of not less than fifty (\$50.00) dollars nor more than five-hundred (\$500.00) dollars with each day of violation constituting a separate offense.


2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
3. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.
4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.


