

# ORDINANCE

O-16-18

BOROUGH OF NORTH CALDWELL, ESSEX COUNTY, NEW JERSEY

**AN ORDINANCE AMENDING CHAPTER 99  
"VEHICLES AND TRAFFIC", §99-4 "SCHEDULE  
II, NO PARKING CERTAIN HOURS", OF THE  
CODE OF THE BOROUGH OF NORTH  
CALDWELL**

**WHEREAS**, it is the recommendation of the Chief of Police that certain changes be made to the Code of the Borough of North Caldwell to further limit the times of day during which parking is permitted on certain Borough streets in order to promote the safety of the Borough residents; and

**WHEREAS**, it is the desire of the Mayor and Council of the Borough of North Caldwell to accept this recommendation and put into place expanded "no parking hours" on certain Borough streets.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of North Caldwell, County of Essex, State of New Jersey as follows:

1. Chapter 99, "Vehicles and Traffic", Section 99-4, "Schedule II, No Parking Certain Hours", shall be amended to restrict hours as follows:

**Schedule II, No Parking Certain Hours.**

No person shall park a vehicle between the hours specified upon any of the following described streets or parts of streets:



Highfield Terrace	Both	2 hrs.	7:00 a.m. to 2:00 p.m., Monday through Friday inclusive	Between West Greenbrook Road and its terminus at the cul-de-sac
Longview Avenue	Both	2 hrs.	7:00 a.m. to 2:00 p.m., Monday through Friday inclusive	Between Squire Hill Road and Sunset Drive
Squire Hill Road	Both	2 hrs.	7:00 a.m. to 2:00 p.m., Monday through Friday inclusive	Between Grandview Avenue and Sunset Drive
Sunset Drive	Both	2 hrs.	7:00 a.m. to 2:00 p.m., Monday through Friday, inclusive	Between Grandview Avenue and its terminus at lands of the West Essex Regional Board of Education
Tanglewood Road	Both	2 hrs.	7:00 a.m. to 2:00 p.m., Monday through Friday, inclusive	Between Longview Avenue and Sunset Drive
Valley View Place	Both	2 hrs.	7:00 a.m. to 2:00 p.m., Monday through Friday, inclusive	Between Sunset Drive and its terminus at the cul-de-sac

2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
3. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.
4. This Ordinance shall take effect immediately upon passage and publication in accordance with law.
