BOROUGH OF NORTH CALDWELL, ESSEX COUNTY, NEW JERSEY

AN ORDINANCE AMENDING CHAPTER 99 "VEHICLES AND TRAFFIC", §99-10 "SCHEDULE VIII, STOP INTERSECTIONS", OF THE CODE OF THE BOROUGH OF NORTH CALDWELL TO ACCEPT STOP SIGNS AT THE CENTRAL AVENUE / GRANDVIEW AVENUE / WEST GREENBROOK ROAD TRIANGLE

WHEREAS, the Governing Body of the Borough of North Caldwell has determined that stop signs be installed at the triangle intersection of Central Avenue/Grandview Avenue/West Greenbrook Road in order to provide for the public safety; and

WHEREAS, the desirability and feasibility of stop signs at the intersection of Central Avenue, Grandview Avenue and West Greenbrook Road has been reviewed and recommended by the Chief of Police, Borough Engineer, Essex County Engineer and Essex County Counsel.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of North Caldwell, County of Essex, State of New Jersey as follows:

1. Chapter 99, "Vehicles and Traffic", Section 99-10, "Schedule VIII, Stop Intersections", shall be amended to provide, as an additional multi-way stop intersection, the following:

Stop intersections designated.

Schedule VIII, Stop Intersections.

The following intersections are designated as stop intersections and shall be posted with STOP signs on the near right side of the street designated herein:

Schedule VIII, Stop Intersections

Intersection	Stop Sign Placement
Central Avenue and West Greenbrook Road and Grandview Avenue	Central Avenue westbound at West Greenbrook Road Grandview Avenue southbound at Central Avenue West Greenbrook Road eastbound at Grandview Avenue

2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
3. This ordinance only amends Chapter 99 "Vehicles and Traffic", §99-10 "Schedule VIII, Stop Intersections" and all other portions of said ordinance shall remain unaltered and in full force and effect.
4. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.
5. This Ordinance shall take effect immediately upon passage and publication in accordance with law.


