

# ORDINANCE

O-7-2021

BOROUGH OF NORTH CALDWELL, ESSEX COUNTY

## AN ORDINANCE AMENDING VARIOUS PROVISIONS OF CHAPTERS 71 AND 45 OF THE CODE OF THE BOROUGH OF NORTH CALDWELL CONCERNING FIELD USE FEES AND SCHEDULING

**WHEREAS**, the Governing Body has reviewed the Code of the Borough of North Caldwell and finds it to be in the best interest of the Borough to amend the regulation of athletic field use fees and scheduling; and

**NOW, THEREFORE, BE IT ORDAINED** By the Mayor and Council of the Borough of North Caldwell, County of Essex, State of New Jersey as follows:

1. Chapter 71 §71-2 of the Code of the Borough of North Caldwell be and is hereby amended to read as follows:

A. Definitions

**Outside organization(s)** - In cases when fields are not used by the Recreation Department or designated Borough sports organizations, non-profit organizations, groups and club teams (must provide documentation of non-profit status) will receive next preference followed by for-profit organizations.

E. (1) Liberty Turf Field Use Fees.

(c) Outside organizations will pay an hourly use fee as follows:

E. (2) Mountain Avenue Field One (1) and Mountain Avenue Field Two (2) Use Fees.

(d) Outside organizations will pay an hourly use fee as follows:

Up to 2 hours	\$75	\$75
Up to 4 hours	\$125	\$125
Up to 8 hours	\$200	\$200

E. (3) Firemen's Field

(a) All Borough Recreation Department sports, activities or events shall not incur a field use fee regardless of sport, season, or field.

(b) Outside organizations will pay an hourly use fee as follows:

Firemen's Field

Up to 1 hour	\$50
Up to 2 hours	\$75
Up to 4 hours	\$125
Up to 8 hours	\$200
Weekly rental 4 or 5 days (4 hours per day)	\$500
Weekly rental 4 or 5 days (8 hours per day)	\$750

E. (4) Magnusson Field

(a) All Borough Recreation Department sports, activities or events shall not incur a field use fee regardless of sport, season, or field.

(b) Outside organizations will pay an hourly use fee as follows:

Up to 2 hours	\$75
Up to 4 hours	\$125
Up to 8 hours	\$200
Weekly rental 4 or 5 days (4 hours per day)	\$500

3. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
4. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed to be valid and effective.
5. This Ordinance shall take effect immediately upon passage and publication in accordance with law.


