The volunteer desires to provide volunteer services for the Churches Outreach Network, and engage in activities related to serving as a volunteer by: Rending some or all of these volunteer services: picking up food, distributing food, clothing, toys, passing out toys, delivering food, lifting heavy items, lifting items, organizing lines, operating machinery if equipped to do so, and various other tasks if called to do so, upon availability. Volunteer understands that the scope of the volunteer's relationship with Churches Outreach Network is limited to a volunteer position, and that no compensation is expected in return for services provided by Volunteer; that Churches Outreach Network will not provide any benefits traditionally associated with employment to volunteer; and that volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of volunteer's services to Churches Outreach Network.

- 1. Waiver and Release:** I, the volunteer, release and forever discharge and hold harmless Churches Outreach Network and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to Churches Outreach Network. I understand and acknowledge that this release discharges Churches Outreach Network from any liability or claim that I may have against them with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to Churches Outreach Network, or occurring while I am providing volunteer services.
- 2. Insurance:** Further I understand that Churches Outreach Network does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of Churches Outreach Network beyond what may be offered freely by Churches Outreach Network in the event of such injury or medical expense incurred by me.
- 3. Medical Treatment:** I hereby release and forever discharge Churches Outreach Network from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Churches Outreach Network.
- 4.
