

**ACCOUNT SERVICE AGREEMENT**

This agreement by and between VeriData Services, Inc. and the company named below "Customer" and / or its designated agent(s), consists of the following understandings and conditions:

Customer certifies and agrees to use the services of and the reports received from VeriData Services, Inc. in compliance with all provisions of the Fair Credit Reporting Act (FCRA), Public Law 91-508, the Americans with Disabilities Act (ADA 1990), the Driver's Privacy Protection Act and all other applicable federal and state laws and regulations including federal and state equal opportunity laws and regulations and further certifies that a copy of "Notice to Users of Consumer Reports: Obligations Of Users Under The FCRA" and of "A Summary of Your Rights Under the Fair Credit Reporting Act" have been made available.

Customer will provide disclosure to applicant/employee before procuring a background report. Customer will obtain written authorization from applicant/employee before procuring a background report. Customer will follow adverse action procedures if a negative employment action is considered.

Customer agrees to only request records for employment, licensing, insurance, tenant screening, and credit purposes, or in connection with a legitimate business need initiated by the consumer.

Customer agrees to properly identify himself when requesting reports and further certifies and agrees that information will be requested only for the subscriber's exclusive use and that inquiries will be made only for permissible purposes, and for no other purpose.

Customer agrees that all reports will be kept strictly confidential. Except as required by law, no information from reports will be revealed to any other person, except a person whose duty it is to pass on the information in relation to which the report was ordered. No information will be requested for the use of any other person. Requests for report information from the person reported on or his representative, will be disclosed as provided for under the Fair Credit Reporting Act, The Americans with Disabilities Act or other applicable laws.

Customer agrees to be responsible for making sure its employees are knowledgeable regarding all laws and regulations, including any applicable state requirements related to record use and retention, including proper authorization, and shall comply with same.

This agreement may be canceled at any time by VeriData Services, Inc. and services terminated, however, such cancellation shall not terminate the customer's obligation to pay for services previously rendered.

Customer agrees that a facsimile of this agreement is as valid as the original.

Customer agrees that it will pay for all services rendered according to the rate schedule in effect at the time services are rendered. Payment is due at date of statement made payable to VeriData Services, Inc. at its address as identified in this agreement. Interest of one and one-half percent (1.1/2%) per month will be due on any payment not made within 30 days of statement date. VeriData Services, Inc. may at its option discontinue service to any customer whose account is not kept current.

If an account goes to collection Customer agrees to pay all cost and expenses including reasonable legal fees. In the event of litigation, such fees and costs shall include cost of trial or appeal. Any legal action or suits will be filed in Gwinnett County, Georgia.

Customer agrees to be solely responsible for any use or misuse of the Service, and Record information received under this agreement, and for compliance with all laws and regulations applicable to such record information. Customer agrees that VeriData Services, Inc. shall not be liable to Customer or any other entity for any lost profits or other damages, fines or penalties, whether general, special, incidental or consequential.

Customer understands and agrees that the accuracy of any information furnished is not guaranteed by VeriData Services, inc. and agrees to release VeriData Services, Inc., its officers, employees, agents of independent contractors from any and all liability, including without limitation, liability or damage from any negligence in connection with procuring, collecting, preparation or communication of such reports, and from any loss or expense suffered by the undersigned resulting directly or indirectly from these reports.
