Consignment Agreement Terms and Conditions

- Items which can be consigned include good quality clothing, shoes, bags, belts, scarves, costume jewellery, sunglasses, hats, etc. All items will be considered but preference is given to Australian and International Designer brands, high end chain store brands, seasonal items and items less than one year old. Shoes must be in excellent condition with little or no wear visible. There are always exceptions to every rule, so if you have any items you're unsure about, please bring them in for assessment. Swimwear, Lingerie and Gym Wear will *not* be accept.
- A one off **administration/processing fee** will be charged on *all new* consignments/drop offs. Fee payable will depend on the quantity of items being consigned. 1 to 5 items \$5, 6 to 15 items \$10, 16 to 25 items \$15, 26 to 50 items \$20, 50 plus items \$25. This fee will be deducted from the first consignment payment.
- The selling price of consigned items will be established between Edit & Refresh and the consignor. The condition of item, age, style, desirability, rarity and original cost will determine the selling price. As a general rule, items will be priced for re-sale at 1/3 of the original purchase price. Designer brands and seasonal items will sell much faster and command a higher price than less expensive chain store brands or out of season items.
- Edit & Refresh reserve the right to reduce the original agreed selling price of an item by up to 30% should it be discovered that the items/garments condition/quality is not as originally perceived (i.e. if stains or marks are discovered on the item/garment that were not obvious during the initial inspection or if the garment/item is broken or damaged in any way or if the item appears older/more worn then originally perceived.
- Acceptable items will be held with Edit & Refresh for a minimum period of 4 weeks (unless other arrangements have been made). If an item is not sold within the first 4 weeks, unless otherwise agreed, it will then be reduced by 10% to 50% depending on the original price. Further reductions will be made to the item, for the remaining consignment period\*\*. It is the consignors responsibility to check on consigned items during the consignment period and/or collect items at the end of the consignment period. Unsold, expired or uncollected items that have already been reduced for sale, will be donated, WITHOUT FURTHER NOTICE, if no contact has been made or attempted.
- Edit & Refresh will receive consignments during normal store hours, no appointment is necessary. We cannot guarantee that we will be able to sort and process your consignments immediately. It is advised that you keep a list of all items that you bring in for consignment for your own records. If you are not provided with an itemised account listing each item and a suggested/agreed sale price at the time of drop off, one will be emailed to you within 7 days of receipt of consigned items. Any items deemed unsuitable will require collection within 5 days from date of drop off (or receipt of emailed consignment list). Uncollected items will be donated to charity.
- Consigned items must be cleaned (or dry cleaned if necessary) and pressed by consignor before being brought into Edit & Refresh. If ironing or cleaning is necessary, a \$10 fee will be deducted from the first consignment payment. Items must be well presented and free of odours (clothing will not be accepted if the smell of smoke, moth balls or any other prominent odour is present). If repairs are necessary, any costs shall be paid by the consignor. Damage to fabric, regardless of item brand or original purchase price, will greatly reduce the sale price of a garment.
- The sale price of consigned items will be split between Edit & Refresh and consignor as follows: Consignor receives \*\*\*40% of the final sale price; Edit & Refresh retains 60% of the final sale price (unless otherwise agreed).
- If you wish to collect unsold items at the end of the consignment period, you must contact us at least **14 days prior** to collecting your items to arrange a suitable time and date for pick up.
- Payments for items sold will be rendered monthly, and will be available for collection after the 10th of each month. Payments must be collected in person from our Chevron Island shop unless other arrangements have been made. If the balance due is \$50.00 or more, payments can be deposited directly into a nominated bank account. You can contact us by text or email anytime after the 10th of each month and we will advise if you have a payment to collect and the amount due. At the time of collection, any unsold or expired items may be returned to you or the sale price of remaining items will be reduced. Cash payments will be held for a maximum of 3 months. Any payments collected after the 3 month period expires, will be available as a store credit only. Payments will be held for a maximum period of 6 months.
- The utmost care will be taken with your garments whilst they remain on our premises. However, as garments will be tried on by potential customers, marks and slight damage can occasionally occur. Edit & Refresh will take no responsibility for any damage which may occur during the consignment period.
- \* Opening times may vary slightly, especially during school holidays or on public holidays, so to avoid disappointment, please call us prior to visiting to confirm hours.
- \*\* Minimum consignment period is 4 weeks. Maximum period or termination of consignment period will be determined by Edit & Refresh but generally ranges from 6 to 8 weeks (varies depending on the item in question).
- \*\*\*Due to the implementation of GST on 1st March 2016, an amendment was made to the commission percentage.
