## 4. First-aid measures

<b>Inhalation</b>	Move to fresh air. Call a physician if symptoms develop or persist.
<b>Skin contact</b>	Remove contaminated clothing immediately and wash skin with soap and warm water for at least 15 minutes. In case of eczema or other skin disorders: Seek medical attention and take along these instructions.

## 5. Fire-fighting measures

<b>Suitable extinguishing media</b>	Water fog. Foam. Dry chemical powder. Carbon dioxide (CO <sub>2</sub> ).

Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Prevent entry into waterways, sewer, basements or confined areas. Following product recovery, flush area with water.</p> <p>Small spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.</p> <p>Never return spills to original container for re-use. For waste disposal, see section 13 of the SDS.</p>

<b>Persistence and degradability</b>	Hydrogen peroxide in the aquatic environment is subject to various reduction or oxidation processes and decomposes into water and oxygen. Hydrogen peroxide half-life in freshwater ranges from 8 hours to 20 days, in air from 10 to 20 hours, and in soils from minutes to hours depending upon microbiological activity and metal contamination. Alcohol ethoxylate: considered readily biodegradable.
<b>Bioaccumulative potential</b>	Expected to be low, will likely degrade before accumulation can occur.
