There are several grants that you re working on for that the Town really needs.

 - -Accountability: Total gallons accounted for January 887,000 which puts us at 87% accountability. We are still having issues with meters. It has been raining so much and these meters are electronic and can take some water, but they have been submerged for long periods of time as we have had a very wet season and because of this, we have been getting some blank readings.
 - -Historical Pumpage 976,100 for the month of January.

 - Texas Water Development Board Drinking Water State Revolving Fund Loan Pressure Tank No.1 Replacement (2017 Loan with 100% Loan Forgiveness): We are making a couple of revisions to the construction plans and will submit them to the Texas Water Development Board by the end of this week.

- TWDB 2018 Hurricane Harvey Emergency Clean Water State Revolving Fund Intended Use Plan: We submitted the application at the end of January without the updated audit. However, the Texas Water Development Board has asked for a copy of the latest audit. The auditor has told me that it could be another week, at least, before the audit is ready. We are going to notify the Board that we will send the audit upon completion.
- ML Insurance Coordination: TML is working to close out the Town's Harvey claim. We are waiting notification on when the final check will be sent.
