- Call to Order by Mayor Leino
- 2. Pledge of Allegiance to the flag of the United States lead by Mayor Ralph Leino. Opening prayer led by Council Member, John Lohman.
- Roll Call Present at the meeting were: Mayor, R. Leino Jr., Aldermen: J. Lohman, M. Greening, A. Rutherford, Belinda Hackleman.
- 4. Citizen Comments.
 - D. Lincoln:
 - 1. Noticed on the accounts payable from the previous meeting, all advertisement is done through the Conroe Courier because this is the paper you have chosen. Why were the elections ad posted in the Houston Chronicle?
 - 2. For future reference, note that you can always opt out of joint election. Ms. Lincoln mentioned that election should run about \$300 and that there should be a ballot upstairs in the attic. Mayor let Ms. Lincoln know that all those election materials are not in the Town Hall.

- 7. Approval of all previous month's minutes Motion to approve all previous month's minutes (April 8, 2019) by Alderman J. Lohmann and seconded by Alderman B. Hackleman. 5 eyes 0 nays. Motion passed.
- 8. Monthly Report:
 - A. Financial Mayor Ralph Leino Jr. Financials were read by Major Leino. General fund, total Income \$984.04. Expenses of \$8,732.22. Utility Fund Income of 21,711.39 with total expenses of \$27,668.31
 - B. Ad Valorem Activity Tax Assessor. This month there was significant issues regarding property taxes, so regular charges are due. Total tax collection for the Month of April: \$1,202.77. Total collections and \$185.02 of that is for Penalty and Interest. Total collection between 10/01/18-04/30/19: \$17,018.71. All taxes are now delinquent as of Feb 1, 2019. The significant issue with trying to get the collections up has to do with ownership of property. In the State of Texas, you do not have to file a deed. If you have a mortgage on your property, the mortgage company can require owners to file. We have a number of people paid cash after the flood and haven't file deeds. Penalty will catch up with them once they file. Interest is 1% of one half per month until paid. Full percent is 15% in July. 2019 Notices from the appraisal district have been sent out and if you don't like your proposed value, you have until May 31st to protest. Properties in Woodloch have more than doubled in value. Anyone who files a protest will have a chance to protest will get a hearing, we will not know how many people will protest and Mr. Griscom will be monitoring it. July 25 is the certification day so from the end of May to the 25th of July is when equalization is done with the Appraisal Review Board. There are less than 80 taxable properties in the Town of Woodloch. Effective Tax calculations will be done after that. Another event will occur this month that will have an impact setting tax rates and that's the Texas Legislator they are meeting now with the deadline of the Sunday before Memorial Day. They have not passed the rate yet, the house has passed it but the senate has not. There are of kinds of changes going on between the communities. The current cap for the Town of Woodloch is 50 cents. They want to take the control out of the local government of setting revenue. School districts are most unhappy to have to have elections to set tax rates. Mr. Griscom will keep the town updated.
 - C. Public Works Operations by Jason Sessum

 Accountability for April is at 84%. 22 Meters were replaced last month. We sent some more meters to be replaced and the turnaround time is 30 days. The next step is to walk around to trouble shoot water in the street to check for chlorine. Woodloch is easy but River Ridge and River Oaks is more difficult. Jason will get to the bottom of it once all registers are changed. Waste Water Report: still standing, no excursions for the month of April. Water Pumpage: 1.1 Million for the Historical pump down from last month. CCR Report needs to be mailed out in July. 2018 Information will be included. Page 5 lists violations. CCR 2016, 2017 due in July 2017 was emailed that, we missed those reports. We got 2018 report out. Lead & Copper report, new addresses were submitted and still had us down for address that do no longer exist. They accepted the address so next year when we send the Lead & Copper report will be cleared. All listed violations have been taken care but it will be cleared next year.
 - D. Engineering Engineering
 - Texas Water Development Board Drinking Water State Revolving Fund Loan –
 Pressure Tank No.1 Replacement (2017 Loan with 100% Loan Forgiveness): The
 construction drawings are complete and ready to be submitted to the State. We are
 waiting on clarification from the Texas Water Development Board on Whether the TCEQ
 or the TWDB will review the drawings.
 - TWDB 2018 Hurricane Harvey Emergency Clean Water State Revolving Fund Intended Use Plan: We have reviewed the final budget and sent it off to the TWDB to continue processing the loan request. As previously noted, we are asking for a loan of \$1,075,000 to construct the Water Wastewater Treatment Plant Phase II. Of this loan amount, \$800,000 will be forgiven and the rest will be borrowed at 0% for 25 years.

Received a letter what application was received and still under review

- GLO Tax Day/Memorial Day Flood Relief (Wastewater Treatment Plant) We have authorized the surveyor to survey the land between South Woodloch and the existing Wastewater Treatment Plant. The surveyor will be picking up elevations, existing features, and boundary markers. Once we have that date then we will be able to lay out the proposed Wastewater Treatment Plant.
- ETJ Boundary Survey. We have authorized the surveyor to identify, in the field, where the ETJ boundary is for the Town. The surveyor will be placing a stake, painting on the roadway, and taking GPS reading where the ETJ crosses a roadway. The surveyor is waiting on decent weather to complete the work.
- Discuss and Approve Accounts Payable
 Motion to approve Accounts Payable made by Alderman A. Rutherford and Seconded by Alderman B.
 Hackleman. 5 eyes, 0 nays. Motion passed
