- 4. Citizen Comments.

Diane Lincoln: You mentioned last meeting regarding the budget, you mentioned that you were going to wait for all the insurance claims to clear the budget. I was wondering if you were going to use those payments to help with operations like it has been done before or are you going to help pay for things like the tractor? How often does the Cultural Education Facility Corporation meet? Those are my questions.

## 6. Monthly Report:

- A. Financial Mayor Ralph Leino Jr. Financials were read by Major Leino. General fund, total expense of \$2,963.54 Utility Fund Income of 25,415.48 with total expenses of \$16,670.66
- B. Ad Valorem Activity Tax Assessor absent. Total collection for the 2018 \$954.65. Total collected from 10/01/18 to 08/31/19: \$20,860.89. Total collected for 10/01/18-09/30/19 \$22,037.56. Total for Sept 20, 2019 was \$1,176.67. 84.1% collected for 2018.
- C. Public Works Operations Jason Absent. Mayor presented report. Accountability report for September is up to 91%. Total Pumpage was 1,112,400. No excursions for the month of September.

Engineering – Engineering – presented by Darrin Fentress

- Texas Water Development Board Drinking Water State Revolving Fund Loan Pressure Tank No.1 Replacement (2017 Loan with 100% Loan Forgiveness): The TWDB requested additional information on September 12<sup>th</sup> and we responded on September 18<sup>th</sup>. The final-revised plans and specifications were submitted to the Texas Water Development Board on September 27<sup>th</sup> and we are awaiting final approval.
- TWDB 2018 Hurricane Harvey Emergency Clean Water State Revolving Fund Intended Use Plan: The TWDB Board of Directors approved the \$800,000 loan forgiveness on Friday, September 6<sup>th</sup>. We understand the Town of Woodloch will close on the loan in November 2019.

The TWDB needs the current year Audit prior to closing.

- GLO Tax Day/Memorial Day Flood Relief (Wastewater Treatment Plant) The Historical Commission authorized a "Shovel Study" of the proposed WWTP site. The grant administrator is working with the City Secretary and Mayor to solicit professional services proposals for the archeological study.
- **WWTP Design/Construction.** Working with the package plant supplier for the design of the new treatment facility. The site design is 50% complete. Will begin the TWDB environmental report when we receive the GLO environmental report from the grant administrators.
