On another note, you sent out a letter about the ordinances, you said people had to come here or be charged for them. Those ordinances have been scanned to the system so I would suggest to upload those ordinances to the Town's website as they are already on PDF form and let people download them. The other thing is when you were talking about the ordinance and fines, I do hope that you enforce these ordinances fairly and to everybody, not just the permits but all the ordinances. There are a lot of people here that are in violation of a lot of different ordinances. I hope that this is approved fairly. - Texas Water Development Board Drinking Water State Revolving Fund Loan Pressure Tank No.1 Replacement (2017 Loan with 100% Loan Forgiveness): Have received final approval for the pressure tank replacement and have started the bidding process. The pre-bid meeting is scheduled for December 3<sup>rd</sup> at 10:00 AM at Town Hall. The Public bid opening will be December 10<sup>th</sup> at 10:00 AM at Town Hall.
- TWDB 2018 Hurricane Harvey Emergency Clean Water State Revolving Fund Intended Use Plan: The TWDB Board of Directors approved the \$800,000 loan forgiveness on Friday, September 6th. The TWDB is looking to close the loan on, or about December 20, 2019. The TWDB will need a copy of the 2018 from the Town prior to closing. We are working with the TWDB and the City on the remaining items needed for closing.
- GLO Tax Day/Memorial Day Flood Relief (Wastewater Treatment Plant Phase I).

Working with the Grant Administrator and the Town to get the Archeologist under contract.

- **WWTP Design/Construction.** Working with the package plant supplier for the design of the new treatment facility. The site design is 60% complete. Will begin the TWDB environmental report when we receive the GLO environmental report from the grant administrators.
