 - **B. Ad Valorem Activity** Tax Assessor Collections this month- \$8994.76, collections up to date for 2022 taxes \$24,188.84. This is 69.61% if total taxes levied. From this point on all balances will accrue penalties until paid. The Appraisal District has asked to update any exemptions amounts for 2023. The Town states their intention that the exemptions in place will not change for tax year 2023 and will make a Resolution on it on 3/9/23.
 - **C. Public Works** S.S. Operations-98% accountability, registers will be programed before the next meeting. Well meter #1 needs to be changed as it's malfunctioning. It is suspected that something is happening on River Oaks and River Ridge that is causing the overflow on N Woodloch manhole. It is recommended to do smoke testing to try to find any issue with the manhole during the summer. It may run about \$10,000-\$20,000 to do River Oaks and River Ridge. Per Melwin he is looking into finding some funds to cover this, it may be up to 1 year before any action can be taken due to fund availability and approval. Rivercrest is moving along well, pump has not arrived yet, should be done by next meeting.
