

Motion was made by Rayma B. Causey, seconded by Tom Wolff,  
that the following Ordinance be passed:

NO. 15

AN ORDINANCE TO AMEND SECTION ONE, OF AN ORDINANCE  
PASSED ON FEBRUARY 20, 1974, REGULATING THE RATES  
TO BE CHARGED BY CONROE TELEPHONE COMPANY FOR LOCAL  
TELEPHONE EXCHANGE TRANSMISSION SERVICE WITHIN THE  
LIMITS OF THE TOWN OF WHISPERING OAKS, TEXAS; FIXING  
AND DETERMINING THE EFFECTIVE DATE OF SUCH RATE  
INCREASES, AND REPEALING ALL ORDINANCES IN CONFLICT.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WHISPERING  
OAKS, TEXAS:

SECTION ONE

That Section One of an Ordinance fixing, determining  
and regulating the rates to be charged by Conroe Telephone  
Company for local telephone exchange transmission service  
within the Town of Whispering Oaks, Texas, as passed on the  
20th day of February, 1974, be amended and as amended to read  
as follows:

"SECTION ONE

FOR LOCAL TELEPHONE EXCHANGE TRANSMISSION  
SERVICE ON RENTAL

- (1) For each one-party business telephone, a monthly  
rate, charge or rental not in excess of . . . . \$15.00
- (2) For each two-party business telephone, a monthly  
rate, charge or rental not in excess of . . . . 13.00
- (3) For each one-party residence telephone, a  
monthly rate, charge or rental not in excess of . . . . 8.75
- (4) For each two-party residence telephone, a  
monthly rate, charge or rental not in excess of . . . . 7.50
- (5) For each four-party residence telephone, a  
monthly rate, charge or rental not in excess of . . . . 6.25
- (6) For each business telephone extension, a  
monthly rate, charge or rental not in excess of . . . . 1.75
- (7) For each residence telephone extension, a  
monthly rate, charge or rental not in excess of . . . . 1.25
- (8) For each commercial PBX, PABX, and inter-  
communication system trunk, a monthly rate,  
charge or rental not in excess of one and  
one-half times the rate charges for one-party  
business telephones.

- (9) For each commercial PBX station, a monthly rate, charge or rental not in excess of . . . . . \$ 1.50
- (10) For each commercial PABX and other inter-communication system station a monthly rate, charge or rental not in excess of . . . . . 2.25
- (11) For semi-public service, a monthly rate, charge or rental not in excess of the charge for one-party business telephone."

SECTION FOUR

EFFECTIVE DATE

This Ordinance shall take effect and be in full force and effect from and after the 1st day of January, 1976.

SECTION FIVE

REPEALING CLAUSE

All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.
