THE TOWN OF WOODLOCH ("TOWN") TO BORROW THE SUM OF \$11,319.35 FROM WOODFOREST NATIONAL BANK AND TO AUTHORIZE THE MAYOR TO SIGN THE PROMISSORY NOTE AND TO AMEND THE 1997-98 BUDGET TO PROVIDE FOR THE REPAYMENT OF THIS LOAN AND AUTHORIZING AUTOMATIC WITHDRAWAL.

WHEREAS, by an Amended and Restated Ordinance authorizing the issuance of "Town of Woodloch, Texas, Sewer System Revenue Certificate of Obligation Series 1994 ("Certificates")" the Town of Woodloch issued, in the aggregate principal amount of \$100,000.00,said Certificates for the purpose of paying contractual obligations for the improvements and extension of the Town's Waste Water Treatment System; and,

WHEREAS, there is now remaining a matured but unpaid portion of the Certificates and the Town desires to arrange for repayment of all remaining unpaid Certificates; and,

WHEREAS, the Town desires to borrow the sum of \$11,319.35 from Woodforest National Bank ("Woodforest") for such purpose at an interest rate of nine (9%) percent to be repaid in two (2) installments of \$3,835.00 and a final installment sufficient to discharge the entire remaining balance of both principal and interest, the first installment to be due and payable on or before June 20, 1998, the second installment on or before July 20, 1998 and the final installment on or before August 20, 1998; and,

WHEREAS, the Town Council desires to amend the 1997-98 Budget to transfer

sufficient monies from the unexpended surplus to the General Fund for the purpose of

discharging this indebtedness during the current 1997-98 year by placing such funds in Account

No. 894-82 for such purpose; and,

WHEREAS, it is hereby found and determined by the Town Council of Town that it

is in the best interest of the Town to borrow such funds from Woodforest to discharge this

remaining indebtedness.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE

TOWN OF WOODLOCH THAT:

SECTION 1. The Mayor of the Town of Woodloch is hereby authorized to borrow

the sum of Eleven Thousand Three Hundred Nineteen and 35/100 Dollars from Woodforest

on the terms and conditions above stated and is directed to amend the 1997-98 Budget to

provide for the repayment of the loan as aforesaid.

SECTION 2. The Mayor is directed to place such funds in Account No. 894-82 and

authorize the Bank to make automatic withdrawals of \$3,835.00 each on June 20, 1998 and

July 20, 1998 and on August 20, 1998 the exact sum necessary to discharge the remaining

indebtedness of both principal and interest.

SECTION 3. This Resolution shall become effective and continue and remain in effect

immediately upon its passage, approval and adoption.
