

Motion was made by Sam Wolff, seconded by Luc Petrich, that the following Ordinance be passed:

NO. 27

AN ORDINANCE BY THE TOWN OF WHISPERING OAKS, TEXAS, CHANGING NAME OF "WHISPERING OAKS LANE" IN SAID TOWN TO "WOODLOCH DRIVE"; PROVIDING THAT IDENTIFYING NUMBER OF LOTS AND IMPROVEMENT REMAIN SAME; AND EFFECTIVE DATE.

WHEREAS, Town of Whispering Oaks, a duly and legally incorporated municipality, encompassing 47.02 acres, Matilda Wilburn Survey, Abstract No. 597, is located in the Southeast part of Montgomery County, Texas, and prior to incorporation, was an existing Subdivision by the same name;

WHEREAS, there is only one street in said municipality, named and designated on the original subdivision plat as WHISPERING OAKS LANE;

WHEREAS, in surrounding and adjacent areas not as suitable for development, the name "Whispering Oaks" is used to designate other subdivisions and means of travel;

WHEREAS, such designations are confusing to the general public and residents in the Town of Whispering Oaks;

WHEREAS, a great majority of the inhabitants of the Town of Whispering Oaks, because of the reasons set out, and for the best interest of the Town, have petitioned the Council to change the name of "Whispering Oaks Lane" to "Woodloch Drive";

WHEREAS, the Town Council has given consideration to said request, is of the opinion that it would be advantageous to Town of Whispering Oaks to approve said change in street name as requested, and no one would be injured or damaged thereby:


THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WHISPERING OAKS, TEXAS:

THAT it is to the best interests of the Town of Whispering Oaks that the Street, "WHISPERING OAKS LANE", be and the same is hereby ordered changed to "WOODLOCH DRIVE", as per plat hereto attached, marked EXHIBIT "A".

THAT the identifying number heretofore assigned to each lot and improvement located thereon shall remain the same.


THAT this Ordinance shall become effective immediately after its passage.

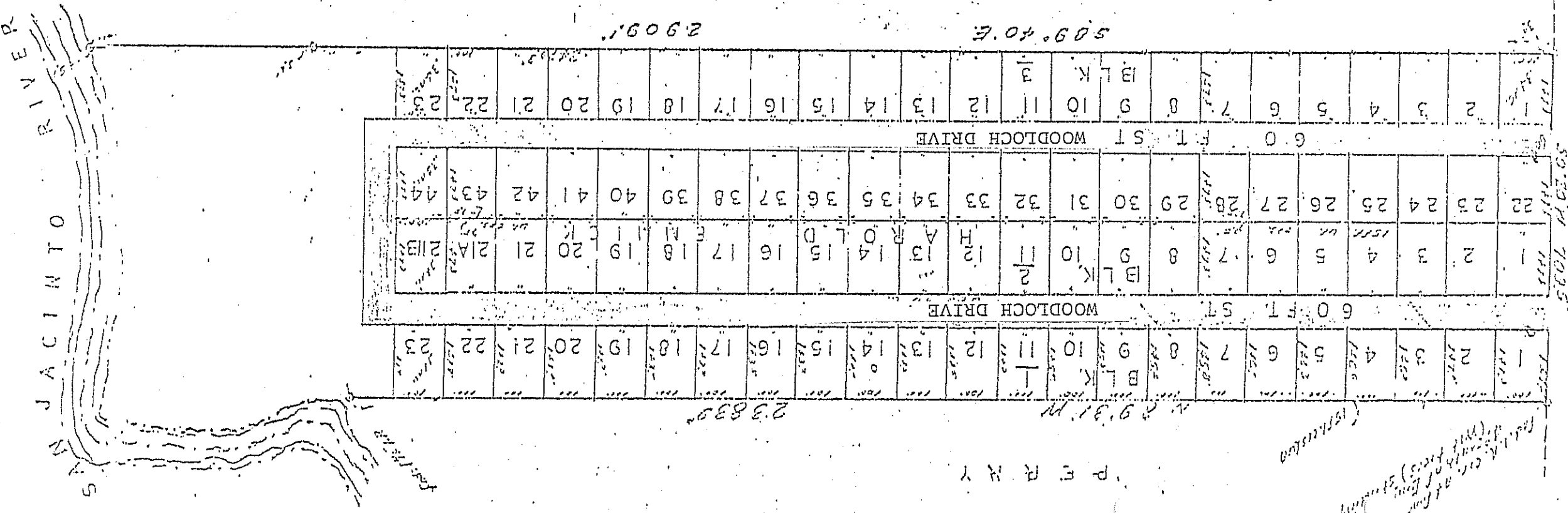
