

Motion was made by Lloyd Shenberg, seconded by  
Pat Campbell, that the following Ordinance be passed:

NO. 50

AN ORDINANCE AMENDING SECTION I, OF ORDINANCE NO. 37,  
PASSED BY THE CITY COUNCIL OF THE CITY OF WOODLOCH, TEXAS,  
ON NOVEMBER 7, 1979; PROVIDING FOR SWIMMING POOL RATES;  
REPEALING ALL ORDINANCES IN CONFLICT, AND PROVIDING  
EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
WOODLOCH, TEXAS:

THAT Section I, of Ordinance No. 37, passed by the  
City Council of the City of Woodloch, Texas, on November 7,  
1979, be amended to hereafter read as follows:

"I.

RATES FOR WATER SERVICE

There shall hereafter be charged and collected each  
month by the City, from consumers of water and water service,  
the amounts of money based on the following rates:

(1) INSIDE CITY LIMITS

Each single family residence, mobile home, duplex,  
and apartment:

- (A) First 15,000 gallons  
of water used . . . . . \$ 9.00 (minimum charge)
- (B) For next 20,000 gallons  
used @ \$1.50 per 1,000 gallons.
- (C) All additional gallons used over  
35,000 gallons @ \$2.00 per 1,000  
gallons.

(2) OUTSIDE CITY LIMITS

Each single family residence, mobile home, duplex,  
and apartment:

- (A) First 15,000 gallons  
of water used . . . . . \$ 15.00 (minimum charge)
- (B) For next 20,000 gallons  
used @ \$1.50 per 1,000 gallons.
- (C) All additional gallons used over  
35,000 gallons @ \$2.00 per 1,000  
gallons.

(3) COMMERCIAL RATE (Inside and Outside City Limits)

- (A) First 10,000 gallons of water used . . . . . \$ 25.00 (minimum charge)
- (B) For next 25,000 gallons used @ \$1.50 per 1,000 gallons.
- (C) All additional gallons used over 35,000 gallons @ \$2.00 per 1,000 gallons.


(4) SWIMMING POOL RATE

- (A) First 25,000 gallons of water used . . . . . \$ 25.00 (minimum charge)
- (B) For next 25,000 gallons used @ \$1.50 per 1,000 gallons.
- (C) All additional gallons used over 50,000 gallons @ \$2.00 per 1,000 gallons."

That all Ordinances or parts of Ordinances inconsistent or conflicting with the provisions of this Ordinance are hereby repealed.

That this Ordinance shall become effective on the 1st day of October, 1981.
