THE APPLICANT ACKNOWLEDGES THE HE/SHE HAS RECEIVED A COPY OF THE PEDDLING AND SOLICITING ORDINANCE OF THE CITY OF FULTON AND AGREES TO ABIDE BY THE SAME. IF FILING ON BEHALF OF A GROUP, THE APPLICANT IS RESPONSIBLE FOR INFORMING ALL PERSONS PEDDLING/SOLICITING IN THE CITY OF FULTON OF THE REQUIREMENTS AND PROHIBITIONS OF THIS ORDINANCE, AND PARTICULARLY THAT:

1. IT IS A VIOLATION OF LAW TO ATTEMPT TO PEDDLE OR SOLICIT AT A LOCATION USING OTHER THAN THE PRIMARY ENTRANCE.
2. IT IS A VIOLATION OF LAW TO ATTEMPT TO PEDDLE OR SOLICIT AT A LOCATION THAT HAS POSTED A SIGN INDICATING 'NO PEDDLERS OR SOLICITORS', OR WORDS OF SIMILAR IMPORT.
3. IT IS A VIOLATION TO ENGAGE IN AGGRESSIVE PEDDLING
4. IT IS A VIOLATION TO REFUSE TO IDENTIFY OR DISPLAY A PERMIT TO A PERSON BEING SOLICITED OR TO A POLICE OFFICER OR OTHER OFFICIAL.
5. THAT ANY VIOLATIONS OF THE PEDDLING AND SOLICITING ORDINANCE CAN RESULT IN THE IMMEDIATE SUSPENSION OR REVOCATION OF ANY PERMIT.

THE APPLICANT ACKNOWLEDGES THAT HE/SHE HAS RECEIVED A COPY OF THE NEW YORK STATE DOOR-TO-DOOR SALES PROTECTION ACT. IF THE APPLICANT IS A SPONSOR FOR JUVENILE PEDDLERS/SOLICITORS, THE SPONSOR IS RESPONSIBLE FOR SUPERVISING AND CONTROLLING THE CONDUCT OF ALL PERSONS NAMED IN THE PERMIT.

THE APPLICANT UNDERSTANDS THAT IF THIS APPLICATION IS MADE LESS THEN 3 BUSINESS DAYS PRIOR TO THE BEGINNING OF PEDDLING/SOLICITING ACTIVITIES, THAT THE PERMIT FEE IS DOUBLE THE NORMAL FEE (FEE INFORMATION AVAILABLE FROM CITY CLERK). IF THE APPLICATION INVOLVES A NO-FEE PERMIT, THE APPLICANT ACKNOWLEDGES THAT HE/SHE CANNOT CONDUCT ANY PEDDLING/SOLICITING ACTIVITIES UNTIL A PERMIT IS ISSUED WHICH MAY TAKE UP TO 3 BUSINESS DAYS.
