### Letter from the President

#### Richard Empson, President, Sherwood Forest Citizens' Association

Now that the New Year has begun there are still many items the subdivision needs to address, and there are new events that are about to start. This is an appeal to all residents in Sherwood Forest to be aware of changes that are taking place in our subdivision and to be ever watchful of unusual happenings and report them either to the City Parish or the proper SFCA Board member who can give you guidance or help solve the issue. One of the main issues within our subdivision, as well as the whole city is blight. **Blight** affects all areas of the city and parish, and unfortunately Sherwood Forest is not spared the effects of blighted properties.

<u>Blight</u> decreases property values and may lead to increased criminal activity. Plus, blight tends to breed more blight. Although there is a unanimous sentiment against blight, fighting blight in Baton Rouge is hard.

The Baton Rouge Municipal Code defines blight as conditions which are hazardous to the health, safety or welfare of the public, and/or conditions which are <u>detrimental to property values</u> or to the quality of the environment.

The road to solving blight begins with a citizen report to 311 and your councilperson. After an initial intake through 311, property inspectors are dispatched to document the evidence of blight. A search for the property's owner(s) also occurs. When the proper owners are found, notice must be provided. The owner is given twenty (20) days to bring the property in compliance with the municipal codes. If correction is not made within twenty days of notice, a second notice is issued in which the owner is ordered to appear at blight court. If a judgment is rendered against the property owner, the city has three options: abatement (cutting the grass); sheriff's sale; or demolition.

Without a total subdivision effort, this issue will continue to escalate. Be vigilant and proactive for the betterment of our subdivision. Don't wait for someone else to act.

## In Sympathy

The SFCA Board of Directors and Committee Members wish to offer their deepest sympathy to the Hartley family (Peter, Jake, Megan and Seth) on the tragic death of Nessa Hartley. The Hartley's moved to Sherwood Forest around 1998 and Nessa was a cherished face at the St. Thomas More Preschool for many years, before retiring to spend time with her grandchildren.

#### "House" versus "Home"

The English word "home" dates back more than 1,000 years; then, as now, its meaning embraces an overall sense of security and safety. Home is a place we seek out, long to return to when away, and fiercely defend from others who might tell us that another place to live would be better. On the other hand, a "house" is a merely a building. It can be made of wood, bricks, or stone. A house is still a house whether there are people living in it or if it is empty. In contrast, a "home" is where our heart is. The word "home" evokes an emotional tie to everything that is placed inside. During quiet times, it is with joy that we recall times shared with our loved ones, parties to celebrate special occasions, and meals shared with family, neighbors and friends. That is why we are all familiar with the phrases "Home Sweet Home", "There is no place like home", "It's so nice to be home", and "Thank you for having me into your home". Our hearts dwell in our "homes", and, by extension in our neighborhood. The word "home" carries more respect and pride in ownership than the word "house" - home owner, home grown, home town, as opposed to house sitter, warehouse, and doghouse.

Sherwood Forest is an older, established neighborhood. Some of the original sections date back to the late 1950s. Older neighborhoods can, and will, decline if the homeowners don't do enough to turn their "houses" into "homes" by maintaining them both inside and out. Beautification efforts can become contagious neighbor by neighbor, street by street, section by section, until the neighborhood as a whole becomes more vibrant. While change is inevitable, and despite the flood of 2016 which affected so many, we should strive to uphold the beauty and integrity of our neighborhood as envisioned by its original founders and architects more

than 60 years ago. We, as neighbors of Sherwood Forest, have common interests that are intertwined as we work together for the betterment of our neighborhood. I suggest that each Sherwood Forest resident consider fostering the concept of "home" in four simple ways:

- Take pride in the ownership of your property, not just on the inside but also on the outside. Regularly maintain your lawn. Edge curbs and walkways, weed gardens, trim shrubs, and keep porches and open carports cleared from clutter. We all benefit from a neat neighborhood with good curb appeal. It will truly turn a collection of "houses" into a collection of "homes". If you need assistance, contact your SFCA block captain or SFCA Board member.
- **Get to know your neighbors**. When the opportunity arises, take the time for a quick hello or a friendly visit. If a situation arises in the future, neighbors who know each other feel more comfortable and more open to discussion. Get to know your block captain since he or she is volunteering time to help ensure the livability of the neighborhood.
- Read the SFCA Newsletter and keep it as a reference. Our newsletter is hand-delivered every Spring and Fall. It contains a wealth of information including SFCA meeting dates, hotline numbers for you to call with concerns, building and other code restrictions, and neighborhood matters that are being addressed for you by the SFCA Board.
- Strongly consider becoming more active in the Sherwood Forest Citizens Association (SFCA). Realize that more assistance and fresh energy is needed to aid the few who do so much for you and our neighborhood on a daily basis. SFCA NEEDS YOU!

Please recognize that each of us can be someone who helps to make a difference so that our neighborhood will be a beacon that calls our families "home" to Sherwood Forest.

## Important Debris Removal Notice

# City Parish Code of Ordinances <u>Section 6:386.1</u> large material to be removed by contractor. (City)

Any person, business or other entity engaged in the business of tree service who in the course of business fells or trims any tree, shall be responsible for the removal of the tree and its components from the premises where the tree was felled, and shall not place the tree or its components or other large lumber refuse on any part of the premises or adjoining servitudes or rights-of-way for removal.

If the contractor fails or refuses to remove a felled tree and/or its components, the owner of the premises shall be responsible for removing the material in accordance with subsection (a)

(a) Anyone violating the provisions of this section shall be guilty of a misdemeanor and subject to a fine of not more than five hundred dollars (\$500.00) or six (6) months imprisonment or both.

(Ordinance Number 9838 &1.2-23-94)

### **Parking Violations**

City Parish ordinances directly state where you should or should not park in a residential A1 subdivision. The security patrol constantly has to issue warnings or tickets to the residents who continue to violate these regulations. These parking violations create an undesirable appearance to the subdivision and in many instances they become a nuisance to those residents who value their home and neighborhood.

Sec. 11:415. - Stopping, standing or parking prohibited; general rules.

**No person** shall stop, stand or park a vehicle, or permit a vehicle registered in his name to be stopped, standing or parked, except when necessary to avoid conflict with other traffic or in compliance with law or the directions of a law enforcement officer or traffic-control device, or parking-control device in any of the following places:

- On a sidewalk
- In front of or blocking a public or private driveway
- Within an intersection
- Within fifteen (15) feet of a fire hydrant
- On a crosswalk
- Within thirty (30) feet upon the approach to any flashing beacon, stop sign, or traffic-control signal located at the side of a roadway
- On the roadway side of any vehicle stopped or parked at the edge or curb of a street
- At any place where official signs prohibit such
- On the driver's left-hand side of any two-way street or highway
- Any place where the curb has officially been painted red
- Within any zone or officially marked place designated as a fire lane at all schools, hospitals, churches and other places of public assembly, as well as commercial and shopping facilities, and apartment complexes
- Alongside a neutral ground curb
- In your front yard
- Too close to the intersection of streets
- On the right of way between the sidewalk and the street or over a sidewalk

  Oversized trucks or 18 wheeler cabs are not allowed to park in the subdivision

### Eye Watch

Our purpose is to work together to make our Sherwood Forest neighborhood a safe place to live. We do this by being aware of our surroundings and reporting crime and suspicious activity when we see it.

We have had an increase in volunteers in 2019. We have approximately 100 SFCA volunteers who have committed to being part of the solution in making Sherwood Forest a safer and a better place to live. Our goal is to have at least one volunteer Eye Watch block captain on each street in Sherwood Forest.

Knowing your neighbors builds community. If you are familiar with your neighbors, you will notice an out-of-place car, a suspicious person, or a potentially dangerous situation. Then, as a neighbor, you will be in a better place to report the issue.

Block captains not only keep an eye on what's going on around their area, but they are also a vital resource and contact point when information needs to be passed on to the appropriate person or organization, such as the civic association, and the crime district and city agencies.

Remember: we can all do our part to deter crime. Lock your car and report any suspicious activity.

## SSO Program Update

The city-parish's SSO (Sanitary Sewer Overflow) Program started up at the very end of December. Even though the system has started, the SSO Program contractors still have outstanding working to do before their work is complete. Our forecast is that the remaining work should be completed by June.

Most of the road work on Sherwood Forest Boulevard is complete. Asphalt has been laid and permanent striping and reflectors have been installed. The remaining work - which includes putting down sod (both on the median and for the home owners' lawns that have been disturbed), replacing the median's broken concrete, and fixing some corners - should be finished early April.

Fixing the broken street corners at Sheraton and Braeburn Drives and Havenwood and Mollylea Drives and cleaning up the Goodwood Boulevard median between Westbrook and Havenwood Drives should be finished in April. The Goodwood Boulevard median work includes cleaning up the gravel left over from when the contractor stockpiled aggregate on Goodwood, replacing the broken electrical vault cover, fixing the ruts in the median, and putting down sod where needed.

The Shelby Drive pump station (next to Miller RV) is now on permanent power. The contractors still has to pick up some piles of dirt and left over aggregate, put down some sod, and remove a fuel tank. The work at this pump station should be finished by late March.

The remaining work at the Christa McAuliffe pump station on Goodwood Boulevard should be finished by the end of March or, early April. The contractor still has to do final grading, install sod, re-instate the fence at Christa McAuliffe, and repair the broken sidewalk.

The remaining work at the Major Oak pump station should be finished in May. The contractor still has to build the foundation for and install the standby generator, install the concrete driveway, do site grading, install aggregate and sod, erect the pump station perimeter fence, and install new sidewalks along Sherwood Forest Boulevard and Major Oak Drive.

We also have met with BNB Development LLC, owner of the property that Boone Services has used for its laydown yard, about the remaining work that Boone Services has to do there in demobilizing from the property and BNB Development's plans to maintain the property.

Last, even though the increased capacity pump stations are now operating, we are still interested in knowing if any sanitary sewer manholes continue to pop when we have a heavy rain, so that Jacobs, the SSO Program manager, and DPW's Department of Environmental Services can correct the issue.

## Road Resurfacing Update

This year there are a number of road upgrades that will be done in Sherwood Forest this year. **The ones that we know about are:** 

- Work has already started on a pilot program to apply a technology called micro surfacing on a number of streets in the subdivision's northeast quadrant. The hope is that micro surfacing will extend the life of low stress streets in the parish another five to ten years. Pot holes for the designated streets are being fixed and the contractor who will apply the micro surface finish will do his work between the end of March and June 25. If you live on one of the streets that will receive the micro surface treatment, DPW will put out door hangers informing you when your street will be surfaced and what you will need to do when the micro surfacing is being applied.
- DPW will be going out for bids this spring to rehab both Sherwood Forest Boulevard between Old Hammond Highway and Florida Boulevard and Goodwood Boulevard between Airline Highway and Stockton Drive. The work will involve removing the old asphalt and installing new asphalt. It will be performed sometime this summer and this fall, under two separate two separate contracts..
- City-parish Metro Council has approved awarding a contract to RJ Daigle to rehab a number of
  streets in various subdivisions, including some in Sherwood Forest. This work will involve
  removing the old asphalt and installing new asphalt. We are waiting for information from DPW
  as to which streets in the Sherwood Forest Subdivision will be rehabbed and when the work will
  start. Once we receive the information, we will inform you of it.

## Garvinea Gerbera Daisy

There is a BRAND NEW Gerber Daisy on the market this year! It has been field proven by our grower in Texas. They bloom 9 months out of the year there, same basic climate as ours. Most Gerberas don't grow well in the ground, but these grow beautifully in the ground there and continuously bloom in rich, well-drained soil and in full sun. Here are some facts you should know when picking a spot in your garden.

#### **Characteristics:**

- **Dimensions:** 18 inches tall and wide.
- **Growth Habit:** Upright, clumping habit, with blooms extending over the top of foliage.
- Foliage: Green foliage, traditional Gerber leaves.
- **Blooms:** Red, Yellow, Pink, and Orange like traditional blooms but more of them and more often.
- Hardiness: Will go dormant in winter but are hardy perennials, coming back next spring.
- **Toxicity:** Non-toxic to family pets.

#### **Care Requirements:**

- **Light:** Full sun to part sun.
- Water: Needs regular watering during hotter months of summer.

- **Soil:** Well-drained soil, rich in organic material is best.
- **Fertilizer:** Use a bloom boosting fertilizer with a high phosphorous content to increase bloom time.
- **Pruning:** Deadheading old blooms will increase bloom production.

#### **Uses:**

- In the landscape as accent plants or borders
- In pots for a pop of color or as a "thriller" centerpiece
- For fresh cut flowers in a vase

# The City of Baton Rouge, Baton Rouge Police Department, and Sherwood Foreest Crime District Pilot Project

The City of Baton rouge and the BR Police Department have partnered with the Sherwood Forest Crime District on an exciting new program. This pilot project will use the same cameras and license plate readers that the Police Department uses to control crime. The cameras will be placed at the entrances to our subdivision.

This system will create a defensive perimeter around the neighborhood. Data from both the cameras and license plate readers will be connected directly into the Police Department's soon-to-be-established Real Time Crime Center.

The project is scheduled to be complete in June. We will keep you updated on the progress of the project.

## Get Organized Curbside

#### ORGANIZING YOUR GARBAGE AND RECYCLING TO ENSURE PROPER PICK-UP

- GARBAGE IS CLASSED AS BAGGED HOUSEHOLD GARBAGE INCLUDING FOOD WASTE AND TRASH WILL BE COLLECTED. NO HOT ASHES/COALS, ELECTRONICS OR BATTERIES.
- Recycling is glass bottles or jars, plastic bottles or containers, cardboard boxes, paper, metal cans and pans and aluminum foil. **No plastic.**
- BULKY TRASH IS FURNITURE, LARGE HOUSEHOLD ITEMS, MATTRESSES, CARPET, FENCING OR LUMBER.
- YARD AND WOODY WASTE IS BRUSH PILES, TREE LIMBS OR PRUNINGS. <u>ONLY</u> <u>RESIDENTIAL GENERATED WASTE WILL BE PICKED UP.</u>
- BAGGED LEAVES AND GRASS IS TO BE PLACED ON THE CURB AND IS CLASSED AS YARD WASTE ONLY. NO BAGGED GRASS OR LOOSE LEAVES
- WILL BE PICKED UP IN OLD GARBAGE CANS.
- BULKY RECYCLABLES IS WHITE GOODS, (STOVES, WASHERS, WATER HEATERS, REFRIGERATORS AND OTHER LARGE APPLIANCES), AND UP TO 4 AUTOMOBILE TIRES.

REMEMBER THAT IF YOU DO NOT HAVE YOUR ITEMS PICKED UP AS SCHEDULED CALL 311 AND REPORT THE OCCURANCE.

#### Sewer User Fee Increase

Effective January 1, 2019, the sewer user fee rate increased by 4% to fund sewer improvements as mandated by the U. S. environmental Protection Agency and the Louisiana Department of Environmental Quality. **The minimum fee is now \$22.65** for the first 400 cubic feet of average water usage, and \$4.10 for each additional 100 cubic feet of average water usage. If your average usage billed does not accurately reflect your current usage, you may contact the **Service Fee Business Office at (225) 989-5378** to request a review of your account.







## Call the Right Number for Assistance

Virtually everyone knows to phone 911 in an emergency. However, there are other numbers you can use to register complaints or seek action to solve a vexing problem.

Use the City-Parish Call Center (311) to report suspected zoning violations (deviations from A-1 code), public safety hazards like potholes and fallen tree limbs, egregious or repetitive parking violations, junked cars, unsightly carports and many more. REMEMBER: YOU MAY REMAIN ANONYMOUS WHEN USING THIS SERVICE!

The number for Baton Rouge City Police is 389-2000. To report suspicious situations that are not time-sensitive call the Sherwood Forest Citizens' Association Security Line, 273-1353. Leave a call-back message, and include your email for online communication.
