• **Court Security Preventing Me from Entering Courthouse**

Dear Judge Eckerle,

Pursuant to the many times you and Court Security prevented from appearing in your court, the six liens/UCC Financing statements **listed above** are still awaiting administrative processing of ratification, so I may remove them from the KY Secretary of State's *Registry* record. I have attached, hereto, the Mar. 7 & 27, 2013 Certifications for each of said liens from Secretary of State Alison Lundergan Grimes.

If you do not promptly ratify the liens, then I have no choice but to file a Criminal Complaint with the county Sheriff, as well as with the **Judicial Conduct Commission**, for your refusal to carry-out your procedural duties.

In another matter, Court Security is preventing me from entering the courthouse to conduct my official business. Your March 13, 2013 order only specifies I am to be escorted by Court Security when conducting my business and I must leave when finished. But I am being prevented from entering to attend my court appearances. Since your 3-13-2013 order, I was prevented from court appearances on April 1, 8, 9, & 15th, 2013. Please resolve this matter with Court Security; allow me to enter the courthouse to conduct my business. And sometimes, my official business is with assisting other citizens. - *Thank you!*
