Heit's Point is a Recognized Service Organization of the Lutheran Church Missouri Synod. The policies of Heit's Point are reflective of the mission. It is the expectation that all staff and Junior Counselors (JC) will govern their personal actions to reflect the mission as well.

As a JC you will be expected to follow the set policies at Heit's Point to ensure that campers, fellow JCs, and staff will be in a safe atmosphere physically, emotionally, and spiritually.

Heit's Point Junior Counselor Policies

1. There is a dress code for JC's. This means that appropriate and modest clothing must be worn while at camp. One piece swimming suits, fingertip length shorts, and appropriate tank tops are required.
2. JC's must stay in their own cabin area and are not permitted in the cabin area of the opposite sex.
3. There are no illicit drugs, alcohol, or smoking at Heit's Point, or any related events.
4. The behavior of the JC must reflect that of a Christian lifestyle. JC's are expected to cooperate with others and respect each other. Any kind of abusive language or words is unacceptable. Language, attitude, and physical actions should at all times compliment the camp's program, philosophy, and values.
5. All medication must be handed into the summer camp medical counselor.
6. Respect for camp property is expected from all JC's.
7. All visitors are required to call the Heit's Point office for permission to visit. Please be sure that any potential visitors understand this policy.
8. iPod, cell phones, or other electronic devices are not permitted at Heit's Point while programs are being conducted. JC's must leave these at home or with the Director of Operations at the beginning of the week
9. There will be a short, brief JC training at the beginning of the camp week.
