HEIT'S POINT JUNIOR COUNSELOR EXPECTATIONS AND CONDUCT AGREEMENT

Heit's Point's Mission statement is: "Strengthening the Connection with the Vine"

Heit's Point's Ministry goals are: to provide a Christ-centered experience that fosters spiritual growth in its guests through their participation in program events, hosted events, and interaction with camp surroundings.

to design and implement program events that are spiritually based and grounded in the Word of God, consistent with Lutheran doctrine, and developed as well as delivered by Heit's Point staff.

Heit's Point is a Recognized Service Organization of the Lutheran Church Missouri Synod. The policies of Heit's Point are reflective of the mission. It is the expectation that all staff and Junior Counselors-(JC) will govern their personal actions to reflect the mission as well.

As a JC you will be expected to follow the set policies at Heit's Point to ensure that campers, fellow JCs and staff will be in a safe atmosphere physically, emotionally, and spiritually.

Heit's Point Junior Counselor Policies

1. There is a dress code for JCs. This means that appropriate and modest clothing must be worn while at camp. One piece swimming suits, fingertip length shorts, and appropriate tank tops are required.
2. JCs must stay in their own cabin area and are not permitted in the cabin area of the opposite sex.
3. There are no illicit drugs, alcohol, or smoking at Heit's Point, or any related events.
4. The behavior of the JC must reflect that of a Christian lifestyle. JCs are expected to cooperate with others and respect each other. Any kind of abusive language or words is unacceptable. Language, attitude and physical actions should at all times compliment the camp's program, philosophy and values.
5. All medication must be handed into the summer camp medical counselor.
6. Respect for camp property is expected from all JCs.
7. All visitors are required to call the Heit's Point office for permission to visit. Please be sure that any potential visitors understand this policy.

8. iPods, cell phones, or other electronic devices are not permitted at Heit's Point while programs are being conducted. JCs must be left at home or with the program director at the beginning of the week.
9. There will be a short, brief JC training at the beginning of the camp week.

I understand and agree with all of the above information and understand that not complying with these policies could result in my dismissal from the program.
